Mr. JOHNSTON said that after RUBY shot OSWALD, he received information from a confidential source whom he declined to identify that RUBY had been co-signer on some loans obtained at Dallas banks by some Dallas Police Department officers. He told this information to Chief of Police CURRY but did not disclose his source to CURRY. He understands that inquiry was subsequently conducted at Republic National Bank of Dallas and the First National Bank in Dallas and it was verified that RUBY had actually been co-signer on some loans obtained by Police officers at those banks. Mr. JOHNSTON said he had no further details concerning this matter.

(Carousel Club) purchased a \$550.00 Cashier's Check # 23517, payable to the estate of H. H. WATSON.

On December 4, 1963, the S & R, Inc. (Carousel) purchased a \$550.00 Cashier's Check # 23998, which was also payable to the estate of H. H. WATSON. These cashier's checks to the estate of H. H. WATSON were deposited in the Republic ////
National Bank, Dallas, in the account of HOWELL H. WATSON by JACK D. WATSON, of Watson & Watson Trusts Account.

In regard to the last cashier's check purchased, the colored porter from the Carousel Club, name unknown, brought the club's receipts into the bank and obtained the cashier's check.

Their records contained no loans, savings accounts, checking accounts for JACK RUBY, JACK RUBENSTEIN, Carousel or Vegas Clubs. However, they did have an account for the S & R, Inc., and for the old Sovereign Club, which account was now closed. It is noted that the only noticeable large deposit was on September 21, 1960, when there was a deposit of \$3,000.00. Prior to this deposit, on August 12, 1960, the account had a balance of \$76.00. On the same date of the deposit of \$3,000.00, there was a check written in the amount of \$2,000.00, leaving a balance of \$1,076.00. On September 23, 1960, a \$1,000.00 check was written, leaving a balance of \$75.00 after a \$1.00 service fee charge had been deducted. It was noted that at the end of December 1960 the account contained \$73.00 and there has been no activity since, with the exception of the deductions of \$1.00 for service charges, and the account now totals \$64.00.

She added that RUBY was somewhat of a nervous person and at times he was friendly and jovial and at other times he seemed depressed and moody.

Miss CARTER knew nothing about RUBY's personal life and, other than her contacts with him at the bank, had no association with him. She knew none of his friends or acquaintances. She said he never mentioned the Dallas Police Department or having friends on that department.

Miss CARTER did not know LEE HARVEY OSWALD and knew of no association between RUBY and OSWALD.

Examination of cancelled checks for December 1, 1963 to date, reflect the account used to pay usual business expenses.

A checking account for RALPH PAUL, 1936 East Abram with a balance of \$2900 is contained in the records. During the period July 24, 1963 to December 16, 1963, regular deposits of \$169.50 were made approximately every week. These deposits consisted of a check drawn on The Bull Pen account. Miss PAT RUCHHEIT, 614 Fair Meadows, Duncanville, Texas, Telephone AX 8-0604, was contacted, at which time she advised that she had telephonically contacted the FBI Office, Dallas, a few days ago and had related information to the effect that she had lived in the same apartment as JACK RUBY in February and March, 1962. She stated that they resided at the apartment building located at Marsalis and Stemmons, and because of this thought the FBI might be attempting to contact her. At the time she contacted the FBI, she pointed out that she could furnish no positive information concerning RUBY and that she had met RUBY only on two occasions.

Miss BUCHHEIT, when interviewed, advised that she could not recall the exact date that she had met JACK RUBY, but could recall seeing him on different occasions around the apartment building located at Marsalis and Stemmons. She could vaguely recall that RUBY lived upstairs and that her apartment was downstairs.

Miss BUCHHEIT stated that she could recall only one specific conversation she had had with RUBY. She stated that this was one evening when a group of her friends were having a little outing near the apartments and could recall RUBY approaching to get together and ask whether they needed anything to drink. She could not recall the exact conversation, but stated that RUBY went to his apartment and returned with a fifth of bourbon for the get-together. She stated that RUBY did not stay around and did not have any lengthy conversation with anyone that particular evening.

She was unable to furnish any other information pertaining to RUBY and stated this was the only time she could ever recall actually having talked to RUBY. She described RUBY as being like any other neighbor in the apartment building and stated that she knew nothing specific regarding RUBY's activities, friends or associates. LEE HARVEY OSWALD was not known to her prior to the assassination and she knew of no connection between RUBY and OSWALD; knew of no association whatsoever between RUBY and any member of the Dallas Police Department; and knew of no one who was a member of the Dallas Police Department who worked for RUBY at any time.

On January 2, 1964, Mrs. FRANCES BIRCH, also known as FANNY BIRCH, Mrs. JAMES R. BIRCH, 9100 Metz Drive, Dallas, who has been previously interviewed as a former employee (stripper) of JACK RUBY, furnished the following information to SAS EDMOND C. HARDIN and PAUL L. SCOTT:

B. APPROX. Mrs. BIRCH stated that since September, 1963, she has been acquainted with one AL/HARVEY, 3025 Toursine Street, Dallas, Texas, who allegedly is a salesman for the M & M Sales, Fort Worth, Texas. She stated that HARVEY formerly dated her daughter, JANE BIRCH, whom he threatened to kill with a pistol on one occasion. He had told Miss BIRCH that he had been treated in the Army for shell shock. He, on one occasion, while at the BIRCH home, pretended to have heart trouble and upon his request was permitted to stay in the BIRCH home for four days. Mrs. BIRCH stated that HARVEY always carried a Derringer pistol on his person and also owns a .38 caliber revolver. She further stated that she considered HARVEY to be a "psycho and a nut". She continued by stating that she did not believe half the things HARVEY said to her and to her daughter.

Mrs. BIRCH related that on November 23, 1963, HARVEY was at her home and prior to leaving, the general conversation revolved around the assassination of the President. At that time, HARVEY stated "I think I'll go home and get my gun and go down and shoot OSWALD". He left and on another occasion, several days later, when he was at her home HARVEY stated that "if RUBY gets out, he'll get the same thing OSWALD got". HARVEY did not indicate that he was planning to or would shoot RUBY if he had the opportunity and did not elaborate upon this statement.

Mrs. BIRCH stated that when interviewed previously by FBI Agents, she did not inform them of the statements made by HARVEY inasmuch as she did not believe HARVEY and considered him to be "crazy" and believed he made the remarks only because of his mentally unbalanced condition. She added that she was voluntarily furnishing this information on January 2, 1964, inasmuch as she felt that HARVEY "might be crazy enough to kill RUBY". She added that she does not believe that HARVEY ever knew OSWALD and has no personal knowledge that he is acquainted with RUBY.
