REURTEL JANUARY FOURTEEN, SIXTYFOUR, REGARDING TESTIMONY OF AGENTS AT RUBY'S BOND HEARING JANUARY TWENTY, SIXTYFOUR. PURSUANT TO DISCUSSION RE AGENTS' APPEARANCE IN ANSWER TO A SUBPOENA FROM THE DEFENSE WITH AAG MILLER ON JANUARY EIGHT, SIXTYFOUR, YOU ARE INSTRUCTED THAT AGENTS WHO INTERVIEWED RUBY ON NOVEMBER TWENTYFOUR, TWENTYFIVE AND DECEMBER TWENTYONE, SIXTYTHREE, ARE TO TESTIFY AS TO THE SPECIFIC FACTS OF THESE INTERVIEWS, STATEMENTS MADE BY RUBY IN THE PRESENCE OF AGENTS AND ANY INFORMATION FURNISHED BY RUBY TO THE AGENTS ON THESE THREE OCCASIONS. THE USA OR HIS ASSISTANT, ACCORDING TO MILLER, WILL BE PRESENT TO INSURE THAT THE AGENTS TESTIFY AS ABOVE STATED. AGENTS MUST CONFINE THEIR TESTIMONY TO THE FACTS AS ABOVE STATED AND UNDER NO CIRCUMSTANCES TESTIFY AS TO THEIR OPINIONS OR CONCLUSIONS REGARDING THE MENTAL OR EMOTIONAL STATE OF RUBY AT THE TIME OF THE INTERVIEWS. WHETHER OR NOT AGENTS SHOULD TAKE INTERVIEW REPORT FORMS  
(FD THREE ZERO TWO) AND NOTES WITH THEM TO COURT WAS  
DISCUSSED WITH THE AAG MILLER. AAG MILLER ADVISED AFTER  
TELEPHONIC DISCUSSION WITH USA SANDERS THAT THE AGENTS  
SHOULD TAKE THE INTERVIEW REPORT FORMS AND NOTES WITH THEM  
TO COURT AND TO TESTIFY FROM THEM OR PRODUCE THEM IF NEEDED  
OR CALLED UPON TO DO SO. YOU WILL THEREFORE HAVE AGENTS  
WHO ARE SUBPOENAED TO TESTIFY TAKE WITH THEM TO COURT  
THE INTERVIEW REPORT FORMS AND NOTES RECORDING THEIR  
INTERVIEWS WITH RUBY. THEY WILL TESTIFY FROM THEM IF  
NEEDED AND PRODUCE ANY OF THESE DOCUMENTS DEMANDED BY THE  
PROSECUTION, DEFENSE, OR THE COURT WHICH IS PROPER WITHIN  
THE DISCRETION OF THE USA WHO WILL BE PRESENT.
