DALLAS PHONE COMPANY RECORDS REGARDING NUMEROUS LD CALLS FROM RUBY-S CAROUSEL CLUB DISCLOSED CALL NOVEMBER EIGHT, SIXTYTHREE, TO DUSTY MILLER, EDEN ROC HOTEL, JE TWO - TWO FIVE SIX ONE, MIAMI, FLORIDA. IDENTITY OF PERSON CALLING NOT AVAILABLE.

MIAMI DETERMINED CALL WAS FOR MURRAY W. MILLER, AKA DUSTY.

NUMEROUS REFERENCES DALLAS INDICES INDICATE MILLER WAS VICE PRESIDENT, INTERNATIONAL BROTHERHOOD OF TEAMSTERS, AND DIRECTOR, SOUTHERN CONFERENCE OF TEAMSTERS, COVERING FOURTEEN STATES,
