SA C. RAY HALL BEGAN INTERVIEW WITH RUBY AT TWELVE FORTY PM, NOVEMBER TWENTYFOUR LAST. INTERVIEW WAS CONCLUDED AT FIVE THIRTY PM. INTERVIEW WAS INTERRUPTED ONE FIFTYEIGHT TO TWO ZERO TWO PM WHEN RUBY WAS CONSULTING WITH ATTORNEY. INTERVIEW AGAIN INTERRUPTED BRIEFLY AT TWO ZERO SIX PM WHEN RUBY WAS AFFORDED PHYSICAL EXAMINATION BY DOCTOR. INTERVIEW INTERRUPTED FROM THREE FIFTEEN TO FOUR THIRTY PM DUE TO ARRAIGNMENT OF RUBY BEFORE JUSTICE OF THE PEACE.

THE TWO FD THREE ZERO TWO INTERVIEW REPORTS SUBMITTED BY SA HALL, BEGINNING ON PAGES THIRTEEN AND ONE HUNDRED SIXTY REPORT OF SA MANNING C. CLEMENTS, NOVEMBER THIRTY, SIXTYTHREE, WERE RESULTS OF THE ABOVE INTERVIEW. SUBJECT MATTER WAS SEPARATED, AFTER DISCUSSION,

FOR REPORTING PUR

PSES, ONE FD THREE ZERO TWO, REFLECTING FACTS OF RUBY'S MOVEMENTS DURING PERTINENT PERIOD, HIS STATEMENTS AS TO THE SHOOTING OF OSWALD, AND BASIC BACKGROUND DATA.

THE SECOND FD THREE ZERO TWO WAS DESIGNED TO INCLUDE DETAILED INFORMATION SUPPLIED BY RUBY AS TO BACKGROUND AND ACTIVITIES PRIOR TO PERTINENT PERIOD.

SA HALL PREPARED TWO TYPED ROUGH DRAFT FD THREE ZERO TWOS AS INDICATED, LATE NOV TWENTYFOUR AND EARLY MORNING HOURS NOV TWENTYFIVE. NOV TWENTYFIVE THE RESPECTIVE ROUGH DRAFTS WERE TYPED BY TWO DIFFERENT STENOGRAPHERS. DATE OF INTERVIEW ON ONE SUCH FD THREE ZERO TWO WAS INADVERTENTLY TYPED AS NOVEMBER TWENTYFIVE, WHEREAS DATE SHOULD HAVE BEEN NOV. TWENTYFOUR. THIS CIRCUMSTANCE FIRST DETECTED BY SA HALL ON REVIEW OF BUTEL JAN SIXTEEN LAST IN WHICH INSTRUCTIONS WERE FURNISHED REGARDING TESTIMONY OF AGENTS IN BOND HEARING, AND ON HIS NOTING BUREAU'S REFERENCE TO INTERVIEWS ON BOTH NOV. TWENTY FOUR AND TWENTYFIVE. AT THIS TIME THE CORRECTION WAS FURNISHED TO BUREAU.
