ON 24 NOV. 1963 I WAS ASSIGNED TO THE BA:
OF THE CITY HALL AT APPROXIMATELY 11:10
FOR THE PURPOSE OF SECURITY IN THE TRANSF
OF LEE HARVEY OSWALD FROM THE CITY
TO THE DALLAS COUNTY JAIL.

I WAS STATIONED NEAR THE JAIL OFFICE DOOR
WHICH EXITS ONTO THE RAMP HEADING IN A
NORTHERLY DIRECTION TOWARD MAIN STREET.

DETECTIVE L. D. MILLER WAS STATIONED

my IMMEDIATE RIGHT AND I WAS THE SEC
PERSON FROM THE DOOR ON THE NORTH SIDE
THE HALLWAY WHICH LEADS TO THE JAIL OFFICE
DOOR. I DO NOT KNOW WHO WAS ON MY LEFT.

AT APPROXIMATELY 11:25AM

CAPTAIN FRITZ ~~OF~~ CAME OUT THE JAIL OFFICE
DOOR AND ASKED WAS ~~IT~~ EVERYTHING ALL RIGHT
AND I ANSWERED "YES SIR". I DO NOT KNOW.
HE WAS SPEAKING DIRECTLY TO ME. TWO
HOMICIDE DETECTIVES WERE HOLDING ONTO THE

CONTACTED BY AN ATTORNEY, MR. TOM HOWE
AND HE WAS EXAMINED BY DR. BIBBER
WHEN WE WERE RELIEVED BY HOMICIDE
OFFICERS, DETECTIVES CHARDY, ARCHER
I ASSISTED IN GETTING THIS MAN FROM

THE 5TH FLOOR JAIL TO THE HOMICIDE
