On Sunday Weyamber 24, 1062 at 11:15 a Cartain Fritz, Lt. R. L. Swain, Tet. J. F. Leavelle, Tet. L. C. Graves and sysolf escented Oswald from Captain Fritz's office to the joil elevator. Fot. Leavelle had been handcuffed to Orwald. Fetrelman C. S. Lewis, Jr., was the elevator eventor as we carried Genald down from the 3rd floor of the city ball to the tacoment. When we got off of the clevator in the bacement, it. D. C. sumin walked out in front of Ceptain Fritz. Let. Peavelle was to Usuald's right and Let. Graves was to Cowald's left, one I was in tack of Gavald shout tirge feet as we approached the door leading from the basement and gril office. Captain Fritz told us to stop, that he was going to check me more time. The captain said, "All right, core on." The welfer out of the deer leading from the barement jail office to the rame where the cars core down into the herement. We had to stop approximately five feet from the driveway of the norm because the car was not in position. When we stonged I saw a flur of scretting and heard a shot. I went around Tet. Groves and grathed Eack Buby by the head. At the time I grathed Buby by the head he was being held by ". J. Verrison, T. T. Ve'illon, E. L. Lovery and W. J. Cutchew. We forced full to the mound and a check was rade for the wearon. To then moved but into the research foil office and put him back on the floor teins held down by the same officers. While being held down on the floor of the tascment jail office, Buby said, "I hope I killed the son-of-a-Litch." I tasked Chief Patchelor if we had better set Futy on the elevator and get him up into the jail. Whicf Batchelor said yes, and Fuby was taken to the elevator. I then went to where Gswald was lying on the joil office floor. 4 doctor was applying artificial respiration. The ambulance people arrived and loaded Uswald on the cot, and I went with the cot to the ambulance.

I then joined Gertain Fritz, Fetertive L. 1. Seek and C. K. Irown in their car and went with them to Ferkland (Providel Horpitel, 5201 Herry Hines Plvd. Hoom our graivel at the horpitel I way told by Gartain Fritz to guard the cast and of the hell of the Thermoney Feer. Oswald was taken to the operating moor and I then royed up to the first floer rain entrance to help maintain security. I was then relieved and rotumed to the outside entrance of the Emerment Peer where I joined Gartain Fritz ard Fet. 7. P. Beck, and we all three returned to the city hell to cur office. I encuend the telerhome and stood by for further orders. At 3:24 or on Fundar Hovember 24. 1963 Tetr. E. L. Poyd, ". 3. Wall and ryself were fold by Gartain Fritz to get Huby out of jail and brought him to Gartain Fritz's office.

I then answered the telephone and stand by for further orders. I was told by Lt. Wells to interview a Fill Defar (stage name) true name, Littler Felano Growe, Jr. I interviewed this reason and found him to be the master of coremonies at the Corourel Club. The over-all content of the interview was the fact that this person was troke and that only was supposed to may him. He did also state that he thought Grande was in the Corousel Club on Movember 20, 1063-Tednesday. Fellar said to could not be definite about this but he felt it was Unvald. This person was released without an affidavit taken. I then stood by for further orders and answered the telephone.

At 19:30 nm Sunday, November 21, 1963 I was told by Cartain Fritz to go home and return at 9:00 am November 25, 1963.
