Dear Mr. Rankin:

In connection with the matter captioned "Jack Ruby, Lee Harvey Oswald - Victim, Civil Rights," the report of Special Agent Manning C. Clements dated November 30, 1963, at Dallas, Texas, sets forth two interviews by Special Agent C. Ray Hall with Jack Ruby.

Special Agent Hall, when preparing to testify at Ruby's bond hearing on January 20, 1964, discovered that a typographical error had occurred in connection with the reporting of the interviews with Ruby in that the interview set forth on page thirteen of the aforementioned report shows the date of the interview as November 25, 1963, when in fact the interview actually occurred on November 24, 1963. In order that your records will reflect the accurate information, it is requested that a correction be made in the report of Special Agent Manning C. Clements dated November 30, 1963, at Dallas, Texas, on page thirteen, showing that the interview took place on November 24, 1963, rather than November 25, 1963.

In the summary captioned "Investigation of Killing of Lee Harvey Oswald, Dallas, Texas, November 24, 1963," a correction should be made on page nine under the caption "A. Movements Following Assassination of President Kennedy." In the first line it is stated that Jack Ruby was interviewed by the FBI on November 24 and 25, 1963. The word and figure "and 25" should be deleted from the end of the line to show that Ruby was interviewed only on November 24, 1963.
