STATE JUDGE J. C. DUVALL, FT. WORTH, TEXAS, ASKED  
FT. WORTH RA IF SO, FT. WORTH, HAD PASSED ON INFO FURNISHED TO  
THEM BY DUVALL FOR RELAY TO FBI. SUCH WAS NOT FURNISHED BY  
SO TO FBI.

DUVALL RELATED /ROY PIKE, WHOM DUVALL HAS REPRESENTED AS  
ATTORNEY IN NINETEEN FORTYTHREE ON RAPE CHARGE, PECOS, TEXAS,  
CAME TO DUVALL'S FT. WORTH RESIDENCE TWO OR THREE HOURS AFTER  
RUBY SHOT OSWALD, PIKE TOLD DUVALL HAD WORKED FOR RUBY AS  
BOOKKEEPER AND PART-TIME BARTENDER AND WAS SO EMPLOYED AT TIME  
OF SHOOTING, WANTED DUVALL'S OPINION AS TO WHAT PUNISHMENT RUBY  
WOULD LIKELY GET. FURTHER, STATED OSWALD HAD BEEN IN RUBY'S  
CLUB ON NUMEROUS OCCASIONS AND HAD BEEN THERE RECENTLY.

INQUIRIES IN DALLAS INDICATE ROY WILLIAM PIKE, AKA MIKE  
RYAN, HAS UNTIL RECENTLY BEEN LIVING WITH ONE RAMONA R. WAGNER, AKA  
TUESDAY RYAN, IS NOW AT TWO ZERO NINE ONE NINE SOUTH NORWALK BLVD,  
ARTESIA, CALIF., PER FORWARDING ADDRESS

THIRTY, SIXTYTHREE, DALLAS, REFLECTS INDIVIDUAL QUOTED PIKE AS SAYING RUBY WAS FRIENDLY WITH JAMES HOFFA AND "THE SYNDICATE," WAS PAYOFF MAN FOR DALLAS PD, ETC; PAGES FIVE THIRTY ZERO - FIVE THREE TWO REFLECT INTERVIEW WITH PIKE NOV. TWENTY-FIVE LAST, IN WHICH HE DID NOT SUBSTANTIATE ALLEGATIONS AND SAID NOTHING RELATIVE TO RUBY-OSWALD CONNECTION.

BUAIRTEL MARCH FIVE LAST RELATIVE TO COMMISSION'S REQUEST TELEPHONE INFO INCLUDES ROY WILLIAM PIKE IN LEADS FOR DALLAS, BASIS FOR HIS INCLUSION NOT BEING KNOWN TO DALLAS. REQUEST BUREAU DIRECT LOS ANGELES INTERVIEW PIKE EXHAUSTIVELY RE ALLEGATIONS MADE TO JUDGE DUVALL OF OSWALD'S HAVING BEEN IN RUBY'S CLUB. ALSO INTERVIEW WAGNER SEPARATELY RE HER KNOWLEDGE OF RUBY, RUBY-OSWALD ASSOCIATION, AND WHAT PIKE HAS TOLD HER.

LOS ANGELES AWAIT BUREAU APPROVAL SINCE RUBY TRIAL IN PROGRESS.
