ENTIRE AFTERNOON SESSION OF RUBY TRIAL DEVOTED TO TESTIMONY OF DR. MANFRED GUTTMACHER, PSYCHIATRIST, ATTACHED TO SUPREME BENCH OF BALTIMORE, MARYLAND, AS DIRECTOR OF COURT CLINIC. AT OUTSET WITNESS TEXTIFIED HIS OPINION RUBY NOT CAPABLE OF DISTINGUISHING RIGHT FROM WWRONG OR KNOWING THE CONSEQUENCES OF HIS ACT AT THE TIME OF THE SHOOTING OF OSWALD. STATED WAS FIRST APPROACHED TO SERVE AS MEMBER OF NEUTRAL PANEL UNDER AUSPICES OF AMERICAN PYSCHIATRIC ASSOCIATION TO EXAMINE RUBY, WAS LATER CONTACTED BY DEFENSE TO SERVE AS DEFENSE WITNESS. STATED HE CALLED DR. ROTSCHAFER, YALE UNIVERSITY PSYCHOLOGIST. INTO CASE AS BEING THE MOST EMINENT MAN IN HIS PARTICULAR SPECIALTY. STATED HE DOES NOT USE CLINICAL PSYCHOLOGISTS IN HIS OWN PRIVATE PSYCHIATRIG PRACTIVE BUT USES ONE IN CASES INVOLVING COURT TRIALS.
