DURING THIS PERIOD, HE WORKED FOR COLLINS FORD ABOUT THREE WEEKS AND AS BARTENDER FOR HILLSIDE CORP. AS BARTENDER FOR TELEPHONE NORTHPARK INN FOR ABOUT THE SAME PERIOD. PIKE REPEATEDLY DENIED MAKING STATEMENTS THAT OSWALD FREQUENTED RUBY-S CLUBS IN DALLAS, OR THAT RUBY WAS FRIENDLY WITH JAMES HOFFA AND WAS PAYOFF MAN FOR DALLAS POLICE DEPARTMENT. STATED HE HAS KNOWN DUVALL TWENTY YEARS, AND TALKED WITH DUVALL THE SUNDAY MORNING FOLLOWING THE SHOOTING ABOUT TWENTY MINUTES, INQUIRING AS TO WHAT WOULD HAPPEN TO RUBY.

PIKE STATED HE HAD HEARD A DOCTOR PRESCRIBE PRELUDIN DIET PILLS FOR RUBY. HE DESCRIBED RUBY AS MENTALLY SICK, CONSTANTLY WORRIED ABOUT CERTAIN TAXES OWED THE GOVERNMENT AND PROBLEMS AT CLUBS. MRS. PIKE STATED SHE MET RUBY ONCE, BUT NEVER KNEW OSWALD, HAD NO KNOWLEDGE OF ANY RUBY-OSWALD ASSOCIATION. INVESTIGATION CONTINUING RE PHONE CALLS, FD THREE ZERO TWOS FOLLOW.
