AT TWELVE THIRTYFIVE PM, MAR TWELVE, ~~EVA GRANT~~ *Texas*, SISTER OF JACK L. RUBY, TELEPHONICALLY CONTACTED THIS OFFICE, AT WHICH TIME SHE PROFESSED GREAT CONCERN FOR THE LIFE AND SAFETY OF HER BROTHER, JACK L. RUBY. SHE CLAIMED THAT RABBI SILVERMAN EARLIER TODAY HAD TALKED WITH RUBY IN HIS CELL AT DALLAS COUNTY JAIL AND DURING CONVERSATION RUBY ALLEGEDLY EXPRESSED THE BELIEF THAT THE JAILERS ASSIGNED TO HIS SECURITY IN THE COUNTY JAIL WERE GOING TO KILL HIM. MRS. GRANT INSISTED THAT THIS OFFICE IMMEDIATELY DISPATCH AGENTS TO THE COUNTY JAIL FOR THE PURPOSE OF PROVIDING PROTECTION FOR RUBY DURING THE REMAINDER OF HIS TRIAL AND ANY FUTURE CONFINEMENT. SHE WAS TACTFULLY ADVISED THAT THIS BUREAU HAD NO AUTHORITY OR RESPONSIBILITY, AND IT WAS SUGGESTED THAT SHE MAKE HER COMPLAINT KNOWN TO SHERIFF DECKER. SHE THEN CLAIMED SHE HAD NO CONFIDENCE IN SHERIFF DECKER AND THAT HE WAS A PART OF THE CONSPIRACY.

SHE THEN BECAME QUITE PROFANE AND INSISTED THAT IF WE COULD PROVIDE PROTECTION FOR MARINA OSWALD SHE CERTAINLY FELT WE SHOULD TRY

TO PROTECT HER BROTHER. IT WAS AGAIN POINTED OUT TO MRS. GRANT THAT THE FBI HAD NEVER AFFORDED PROTECTION TO MARINA OSWALD, WHICH SHE CLAIMED SHE DID NOT BELIEVE. SHE AGAIN BECAME VERY PROFANE, AND STATED SHE WAS GOING TO APPEAR ON TELEVISION THIS AFTERNOON AND EXPOSE THE FBI FOR PROTECTING MARINA OSWALD AND REFUSING TO PROTECT HER BROTHER.

BOTH SHERIFF J. E. (BILL) DECKER AND DIST ATTY HENRY WADE HAVE BEEN FURNISHED THE INFORMATION FURNISHED BY MRS. GRANT.
