Enclosed herewith are copies of following records obtained on 3/12/64, from [redacted] Jewish Children's Bureau, 1 South Franklin, Chicago, Illinois, by SA HERBERT F. BRIICK: *see*

One 2-page document pertaining to JOE RUBENSTEIN and carrying the date on the upper right-hand corner, February 26, 1923; ten copies of handwritten information slips pertaining to the RUBENSTEIN family compiled by unidentified employees of the Research Bureau. *family*

[redacted] advised Agent BRIICK that to the best of her knowledge these are the only records extant concerning the RUBENSTEIN family in their dealing with the various social service agencies in Chicago in the 1920s. She advised that all other records have been destroyed. *MCT-14 44-24016-1312*

The Chicago Division is preparing appropriate
FD-302s and a letterhead memorandum for submission to the
President's Commission which will be forwarded at the
earliest possible time.

The Laboratory is requested to prepare four
photographic copies of each of the submitted items, two
for the President's Commission, one for the Bureau files,
and one for the Dallas Division Office.

For information of the Bureau and the Dallas
Division the Chicago Division has photostat copies in its
possession of numerous summons issued by the Circuit Court
of Cook County (Juvenile Court) in the 1920s in matters
pertaining to members of the RUBENSTEIN family including
subject JACK RUBEN. These summons pertain to appearances
by various family members at the Juvenile Court in connection
with the children of the RUBENSTEIN family and other care and/or
custody by the Jewish Home Finding Society, Chicago, Illinois.
These items are not being forwarded at the present time since
the President's Commission has made no specific request for
these records. The original of these records has been re-
turned but the above mentioned photostat copies are being
maintained by the Chicago Division in the event that a
request be made in the future for such material.
