Re Bureau airtel 4/8/64 and accompanying letter from the President's Commission relative to telephone call allegedly made by EARL RUBY to Triangle Manufacturing Company, Oshkosh, Wisconsin, on 11/1/63 on behalf of JACK RUBY.

The telephone call referred to is apparently that call to Oshkosh referred to on page 131 and page 139, report of SA MANNING C. CLEMENTS, 3/28/64, at Dallas. It is noted such was a station to station call from the telephone at Cobo Cleaners, Detroit, Michigan operated by EARL RUBY and his partner, GEORGE MARCUS.

By airtel 3/20/64, Milwaukee Office furnished Dallas with FD-302s reflecting information from Dun & Bradstreet relative to Triangle Manufacturing Company and interview with DONALD L. SULLIVAN, president of the company. It is noted the company is reported to manufacture sleeve and specialty bearings and that SULLIVAN stated RUBY and MARCUS are unknown to him; that Cobo Cleaners is not recorded as a customer. SULLIVAN volunteered it is not uncommon for a user to contact the factory when something goes wrong with a product in which Triangle bearings are used, in which case the user is referred to the nearest distributor to him.
