CP OR ANY OTHER SUCH ORGANIZATIONS, AND IS IN FACT A LOYAL AMERICAN
CITIZEN. HE STATED HE COULD FURNISH NO INFORMATION AS TO ANY INDIVIDUAL
OF THE SAME NAME WHO MIGHT BE ASSOCIATED WITH THE CP IN CHICAGO.
