Dallas will handle identification of the Platellite Engineering Company.

Los Angeles will handle the request for identification of Herbert Eden and submit results by appropriate inserts or FD-302's to Dallas for inclusion in the Dallas report. The request of the Commission must be handled on an expedite basis. Set out any necessary leads by teletype.
