This individual then talked briefly to one of the employees in the delicatessen, and MARTIN did not hear the conversation or gain any knowledge as to whether or not these two men knew each other.

After a few minutes, RUBY again returned to the booth where the youths were sitting and rudely grabbed the · · . . newspaper and took it without asking. He appeared to again assessment look at something in the classified want-ad section and again went to the pay phone and either made or attempted to make a phone call. Linen RUEY returned the newspaper this time, he noticed that the youths were somewhat irritated and in a bragging fashion identified himself as owner of the Carousel and Vegas Clubs in Dallas and showed the group an advertisement in the newspaper about his clubs. He then took out some complimentary passes to the clubs and taunted the youths with a promise to give them some tickets.
