Who his mother states was responsible for her meeting RUBY, stated that he absolutely did not know RUBY, nor had he ever had any contact with him whatsoever.

With regard to his mother, he said that she is an alcoholic who has been arrested on several occasions by the Chicago Police Department and who has attempted suicide twice. When drinking, she is a chronic trouble-maker who apparently enjoys the attention she gets when creating a disturbance. He considers her to have pyromaniacal tendencies. He stated that she has previously "made up stories" but he has never known her to have previously contacted any law enforcement body with her fabrications.
