"O.K. I LIED. GIVE ME THE TRANSCRIPT (OF THE FIRST GRAND
JURY HEARING). I AM NOT AS SHARP AS YOU ARE, "THE TRANSCRIPT
DISCLOSED ANDREWS TOLD THE GRAND JURY IN HIS SECOND APPEARANCE.

THE STATE SATURDAY ALSO INTRODUCED A "DUBBED TAPE" OF A
CONVERSATION ANDREWS HAD WITH ROBERT SCOTT, A REPORTER FOR
WRKL RADIO IN BOSTON, MASS.

SCOTT TOOK THE STAND AND SAID THE TAPE WAS NOT AN ORIGINAL
AND HAD BEEN "DUBBED" FOR PRESENTATION ON THE AIR. UNDER
QUESTIONING BY THE DEFENSE, SCOTT SAID ANDREWS DID NOT KNOW HIS
VOICE WAS BEING RECORDED.

IN THE TAPE, ANDREWS TOLD HIS THEORY OF THE ASSASSINATION,
WHICH CLOSELY RESEMBLED GARRISON'S THEORY.
HE SAID HE HAD LOCATED TVO OF THREE FIGURES IN THE ALLEGED
NEW ORLEANS COMSPIRACY TO KILL PRESIDENT KENNEDY, WHO HE HAD
COMMISSION ABOUT "A MEXICAN AND CLAY BERTRAND" BUT DID NOT
IDENTIFY THE THIRD MAN.

ANDREWS, IN THE DUBBED TAPE, ALSO SAID LEE HARVEY OSWALD DID
NOT KILL KENNEDY. "HE WAS ONLY A DECOY, A PATSY. "ANDREWS SAID
ON THE TAPE. THE SAME THEORY HAS BEEN EXPOUSED BY GARRISON.

ANDREWS ALSO TOLD SCOTT IN THE TELEPHONE CONVERSATION THAT
HE DID NOT BELIEVE OSWALD WAS A MEMBER OF THE FEI OR CIA AND
THEORIZED THE SHOTS IN DALLAS WERE FIRED FROM THREE DIFFERENT
PLACES. 3-14-67
