NEW YORK (AP) - THE STATE IS READY TO BRING CHARGES AGAINST CLAY L. CLAY IN CONNECTION WITH THE ASSASSINATION OF PRESIDENT JOHN FITZGERALD KENNEDY, A TEXAS COURT HAS DECIDED.

CLAY, 47, IS BEING HELD IN THE COUNTY JAIL IN DALLAS. HE WAS ARRESTED IN THE APARTMENT OF JOSEPH P. PENNINGTON, THE CRIMINAL DISTRICT COURT CLERK, IN DALLAS, TEXAS, ON NOVEMBER 22, 1963.

CLAY'S ATTORNEY, JAMES H. HARRIS, SAID HE WILL REQUEST THAT CLAY BE RELEASED ON BAIL. HARRIS SAID HE WOULD LIKE TO SEE CLAY IN HIS HOME IN NEW YORK CITY, AND ONE OF HIS GOALS IS TO GET CLAY OUT OF THE STATE TO ALLOW THE GOVERNOR TO ESCAPE.

CLAY IS CURRENTLY IN NEW YORK CITY ON A VISIT TO HIS WIFE, MARY, AND TWO CHILDREN. CLAY WAS CALLED TO DALLAS BY PENNINGTON, THE STATE CLERK, AS A WITNESS IN THE ASSASSINATION OF PRESIDENT KENNEDY.

CLAY SAID CLAY LEARNED ABOUT THE ASSASSINATION OF PRESIDENT KENNEDY AT ABOUT 10 P.M. ON NOVEMBER 22, 1963. CLAY SAID HE WAS AT HIS HOME IN NEW YORK CITY AT THAT TIME.

CLAY SAID HE HAD BEEN QUESTIONED BY SHERIFF SAUL B. BRYSON IN NEW YORK CITY WITHOUT A LAWYER A FEW YEARS AGO IN NEW YORK CITY. BRYSON CLAIMING THE NEW YORK POLICE HAD TERRORIZED HIM AND HARASSED HIM SO THAT HE GOT OUT OF THE STATE.

CLAY SAID HE HAD ALSO FILED SUIT AGAINST BRYSON AND HIS CHIEFS.

"IS IT A FACT," ASKED BRYSON, "THAT YOU WERE RECENTLY TROUBLED BY A COMMUNIST ORGANIZATION--THE NEW YORK POLICE?"

"YES," CLAY SAID.

"PARTICULARLY RECENTLY," SAID BRYSON.

"YES," CLAY SAID.
