 NEW ORLEANS (UPI)--ANOTHER WITNESS WHO HAS HAD HIS MOMENTS WITH HYPNOTISM IS NEXT ON THE STAND MONDAY IN DIST. ATTY. JIM GARRISON'S ATTEMPT TO PROVE CLAY L. SHAW CONSPIRED IN 1963 TO ASSASSINATE PRESIDENT JOHN F. KENNEDY.

THE WITNESS IS PERRY RAYMOND RUSSO, 27, A FORMER LIFE INSURANCE SALESMAN, AND HE IS A KEY TO GARRISON'S ENTIRE CASE. RUSSO HAS SAID HE HEARD SHAW, LEE HARVEY OSWALD AND DAVID W. FERRIE PLOT TO KILL THE PRESIDENT.

RUSSO HAS SAID HE HAS BEEN HYPNOTIZED SEVERAL TIMES. ANOTHER OF THE STATE'S CHIEF WITNESSES, CHARLES I. SPIESEL OF NEW YORK, TESTIFIED LAST FRIDAY HE HAD BEEN HYPNOTIZED SEVERAL TIMES DURING THE PAST 15 YEARS.

ASST. DIST. ATTY. JAMES ALCOCK, WHO IS HANDLING MOST OF THE PROSECUTION IN COURT, SAID EXAMINATION AND CROSS EXAMINATION OF RUSSO MAY TAKE TWO OR THREE DAYS.

"WE WILL BE THROUGH WITH HIM SOONER THAN THAT," CHIEF DEFENSE COUNSEL F. IRVIN DYMOND SAID.

SHAW, 55, CHARGED WITH CONSPIRING BETWEEN SEPT. 1 AND OCT. 10, 1963 WITH OSWALD AND FERRIE, AN AIRLINE PILOT, TO KILL KENNEDY. BOTH OSWALD AND FERRIE ARE DEAD.

ALCOCK SAID THE CASE IS MOVING ALONG FASTER THAN HE EXPECTED. HE SAID IT WILL NOT, IN ANY CASE, LAST THE TWO MONTHS JURORS WERE TOLD THAT IT MIGHT.

GARRISON ISSUED A SUBPOENA OVER THE WEEKEND THAT RENEWED HIS REQUEST FOR PRESIDENT KENNEDY'S AUTOPSY REPORT AND RELATED PHOTOS AND X-RAYS NOW IN THE NATIONAL ARCHIVES.

IT ALSO ASKED FOR THE RIFLE THAT KILLED KENNEDY, HIS CLOTHING, A SPENT BULLET, THE BELL AND HOWELL MOVIE CAMERA USED BY ABRAHAM ZAPRUDER IN DEALEY PLAZA, KENNEDY'S DEATH CERTIFICATES, X-RAYS OF FORMER GOV. JOHN CONNALLY OF TEXAS AND SEVERAL ASSASSINATION RECONSTRUCTION EXHIBITS.

A HEARING ON THE SUBPOENA WILL BE HELD NEXT FRIDAY BY JUDGE CHARLES W. HALLECK IN THE WASHINGTON, D.C., COURT OF GENERAL SESSIONS. HALLECK HAS PREVIOUSLY REFUSED TO PERMIT THE AUTOPSY EVIDENCE TO LEAVE THE ARCHIVES UNLESS GARRISON COULD PROVE THEY ARE NECESSARY FOR HIS CASE.

THE SUBPOENA SAID THE ITEMS ARE NECESSARY AND MATERIAL TO THE PROSECUTION... THAT THE ITEMS WILL REVEAL THAT JOHN F. KENNEDY WAS STRUCK BY BULLETS FIRED FROM AT LEAST TWO DIRECTIONS. THEY WILL FURTHER DEMONSTRATE THAT THE FATAL HEAD WOUNDS WERE THE RESULT OF SHOTS FIRED FROM THE FRONT OF PRESIDENT KENNEDY.

THE WARREN COMMISSION CONCLUDED ON THE BASIS OF MORE THAN 20,000 INTERVIEWS WITH WITNESSES THAT OSWALD KILLED KENNEDY IN DALLAS NOV. 22, 1963 AND THERE WAS NO EVIDENCE OSWALD WAS PART OF A CONSPIRACY.

SPIESEL, A NEW YORK CITY ACCOUNTANT WHO SAID HIS ENEMIES AND OTHER PEOPLE HAD TRIED TO HYPNOTIZE HIM FOR THE PAST 15 YEARS, WAS EXCUSED AS A STATE WITNESS SATURDAY AFTER LEADING THE JURY INTO TWO FRENCH QUARTER APARTMENT HOUSES. THE SEARCH WAS FOR AN APARTMENT IN WHICH SPIESEL SAID HE HEARD FERRIE AND SHAW AT A JUNE, 1963 PARTY DISCUSS KILLING KENNEDY WITH A HIGH POWERED RIFLE.

SPIESEL WENT INTO TWO BUILDINGS. HE SAID THE SECOND BUILDING WAS "SIMILAR IF NOT THE SAME" APARTMENT HOUSE IN WHICH THE PARTY WAS HELD BUT HE COULD NOT FIND AN APARTMENT LIKE THE ONE HE DESCRIBED.
