(SHAW)  
 NEW ORLEANS -- PERRY RAYMOND RUSSO, THE STATE'S STAR WITNESS  
 AGAINST CLAY C. SHAW, TODAY REPEATED HIS STORY OF HEARING SHAW  
 PLOT TO KILL PRESIDENT JOHN F. KENNEDY, BUT ADMITTED UNDER  
 CROSS-EXAMINATION IT COULD HAVE BEEN A BULL SESSION.  
 RUSSO, POINTING TO THE 55-YEAR-OLD RETIRED NEW ORLEANS  
 BUSINESSMAN, IDENTIFIED HIM AS THE "OLEN BERTRAND" HE HEARD DISCUSSING  
 HOW TO ASSASSINATE KENNEDY IN 1963 WITH LEE HARVEY OSWALD AND  
 DAVID V. FERRIE.

"IS IT NOT TRUE THAT THE CONVERSATION COULD HAVE BEEN A BULL  
 SESSION JUST AS WELL AS SOMETHING SERIOUS?" DEFENSE ATTORNEY F. IRVIN  
 DYMOND ASKED HIM.

"YES, SIR," RUSSO REPLIED.

HE ALSO AGREED WITH DYMOND THAT FERRIE, A FORMER AIRLINE PILOT  
 WHO DIED OF A CEREBRAL HEMORRHAGE IN 1957, WAS "A LITTLE ON THE CRAZY  
 SIDE."

RUSSO ORIGINALLY TESTIFIED AT SHAW'S PRELIMINARY HEARING IN 1967.  
 HE GENERALLY REPEATED THE TESTIMONY MONDAY.

HE PICTURED SHAW AS A DOMINATING PERSONALITY OBSESSED WITH KILLING  
 KENNEDY OVER "THE CUBA THING" AND AS A PARADOX OF A PERSON.

"HE WORE BAGGY AND DIRTY CLOTHES FREQUENTLY, BUT HE WAS SHARP."  
 RUSSO SAID. "A MAN WHO COULD SPEAK 11 LANGUAGES AND WHO HAD FIVE  
 DEGREES SHOULD HAVE BEEN ABLE TO DO BETTER. HE WAS TURNED TOWARD  
 THE FANTASTIC."

"DO YOU MEAN FERRIE WAS A LITTLE ON THE CRAZY SIDE?" DYMOND  
 ASKED.

"I ALWAYS THOUGHT SO," RUSSO SAID.

ASST. DIST. ATTY. ANTHONY SCIAMBRA TODAY READ INTO THE  
 RECORD A MEMORANDUM WHICH HE SAID COVERED HIS FIRST QUESTIONING OF  
 RUSSO ON FEB. 25, 1967.

SCIAMBRA SAID HE SHOWED RUSSO A PICTURE OF SHAW AND RUSSO  
 IDENTIFIED HIM.

THE MEMORANDUM MADE NO MENTION OF THE MEETING IN FERRIE'S  
 APARTMENT BUT RUSSO TESTIFIED AT LENGTH ABOUT IT TODAY.
