 HACKETT, IN HIS COURT A 10-MIN JURY TO ACQUIT GRAY L. SHAW OF
 CHARGES OF CONSPIRACY WITH OSWALD.
 PORTER, NOW IN HIS 40s, LIVES IN NEW YORK. THE FEDERAL GOVERNMENT
 SAID HE IS ACCUSED OF A \$40,000 BUSINESS DEAL IN NEW YORK.
 SHAW, NOW IN HIS 30s, IS ACCUSED OF CONSPIRING WITH OSWALD IN NEW ORLEANS IN 1963.
 HE SAID HE MET OSWALD WHEN HE VISITED AN ALLIED CONTRACTOR, OF FERRY RAYMOND MUSCO,
 AND SAID SHE DID NOT REMEMBER OSWALD WHEN ANY OF THE THREE, BUT
 MET HIM IN NEW ORLEANS IN 1963. SHE SAID SHE NEVER TALKED HER ABOUT ANY OF HER FRIENDS.
 SHE SAID SHE NEVER MET OSWALD IN NEW YORK, BUT SHE LOOKED LIKE A "TRIPLET."
 AS MRS. PORTER DESCRIBED HIM, THAT HE NEVER MET OSWALD AND ALIAS "LEON" AND THAT HE
 VISITED HER IN NEW YORK IN 1963. SHE SAID SHE MET OSWALD IN NEW ORLEANS.
 THE NEW ORLEANS DISTRICT ATTORNEY SAID HE MET OSWALD IN NEW ORLEANS.
