NEW YORK (UPI) -- THE AUTHOR OF A NUMBER OF BOOKS ON THE DEATH OF PRESIDENT KENNEDY SAYS THERE IS EVIDENCE CONTRADICTING THE WARREN COMMISSION'S CONCLUSION THAT LEE HARVEY OSWALD WAS THE ASSASSIN.

HAROLD WEISBERG, AUTHOR OF "WHITEWASH" AND "FRAMEUP," SAID FRIDAY THAT A "SPECTROGRAPHIC" ANALYSIS OF THE THREE BULLETS ALLEGEDLY FIRED BY OSWALD FROM A SIXTH-FLOOR WINDOW OF THE TEXAS BOOK DEPOSITORY "MEANS THE END OF THE GOVERNMENT'S ACCOUNT OF THE ASSASSINATION."

WEISBERG SAID ONE OF THE BULLETS LODGED IN A CURBSTONE ABOUT 400 FEET FROM THE PRESIDENT'S CAR.

"ALL OF OSWALD'S BULLETS HAD COPPER JACKETS," WEISBERG SAID, "BUT THERE WAS NO TRACE OF COPPER ON THE CURBSTONE."

WEISBERG SAID THE BULLET'S ANGLE OF ENTRY INTO THE CURBSTONE SHOWED THAT IT COULD NOT HAVE BEEN FIRED FROM THE SIXTH-FLOOR WINDOW. HE SAID THE EVIDENCE WAS RELEASED TO HIM BY THE GOVERNMENT AFTER HE FILED A LAWSUIT UNDER THE FREEDOM OF INFORMATION ACT.

"THE WARREN COMMISSION HAD PROOF OSWALD WASN'T THERE IN THAT WINDOW BUT CHOSE TO IGNORE IT," WEISBERG SAID IN URGING A CONGRESSIONAL INVESTIGATION OF THE ASSASSINATION.

WEISBERG SPOKE AT A ROOSEVELT HOTEL NEWS CONFERENCE TO ANNOUNCE A WEEKEND CONFERENCE ON "THE POLITICS OF ASSASSINATION" SPONSORED BY NEW YORK UNIVERSITY LAW SCHOOL.
