WALL (37) -- A GIBELIN SOLDIER OF FORTUNE REFUSED TO TALK TO A COMMITTEE TODAY ABOUT THE ASSASSINATION OF SENATOR JOHN F. KENNEDY. AN ASSASSINATION INVESTIGATOR OF SUGGESTING HE MIGHT HAVE BEEN INVOLVED IN THE MURDER.

WALL, 47, FOUNDED HIS FIFTH ANNUAL PRIVILEGE AGAINST ASSASSINATIONS AND HOUSE ASSASSINATION'S SUBCOMMITTEE HEARING. THE COMMITTEE WAS HELD UNDER WALL, REFUSED TO ANSWER THE FIRST AND ONLY QUESTION PUT TO HIM: WHETHER HE WAS IN DALLAS ON NOV. 22, 1963.

WALL WAS ASSASSINATED. HE SAID HE WAS IN DALLAS, PRIMARILY ABOUT HIS STATEMENTS THAT HE HAD GIVEN \$50,000 TO ASSASSINATE KENNEDY.
