It was concluded that Qol03 is a fraudulent and counterfeit card. It was prepared from OSTALD'S original notice of classification in his name and contained in his vallet. From the original notice of classification in OSTALD'S mame, at least three negatives were prepared. The three segatives are part of item 228 in the inventory submitted by the Dallas Office. These three negatives were used in preparing the face of Gc102.

The reverse side of QclO3 was not prepared from OSVALD'S original notice of elassification or from OSVALD'S original registration certificate in his vallet nor does the data on the back of Qc103 conform to the descriptive data on the back of OSVALD'S original registration certificates It is noted that the reverse side of Qc103 is the form of a registration cortificate and is not the reverse side of a notice of classification card, Hence, it is apparent that OSTALD had at least one other original registration certificate,
