In connection with the exhibits which are too indistinct for adequate handwriting comparison, the original documents or a clear photograph thereof should be obtained and submitted. For your investigative assistance in this matter, some handwriting similarities were noted between the known writings of OSWALD and the endorsements on the warrants in Qc68 dated 8-9-63, 8-26-63, 9-3-63, 9-13-63, 9-23-63 and 10-1-63. Also, some handwriting similarities were noted between the known writings of OSWALD and the signature on LA Form 1B-2 dated 9-3-63 in Qc69 and ~~LA Form 1B-2~~ dated *8-27-63*.

It was concluded that LEE HARVEY OSWALD, K4 and K5 in this case, wrote the signatures and endorsements on Qc68 through Qc70 except no conclusion was reached with respect to the warrants in Qc68 dated 8-9-63, 8-26-63, 9-3-63, 9-13-63, 9-23-63, 10-1-63 and on the LA Forms 1B-2 in Qc69 dated 8-27-63 and 9-3-63 which are too indistinct for an adequate handwriting comparison.

The submitted evidence is retained.

- ① Concluded that Lee Harvey Oswald, KY and KS prep the endorsements on warrants dated 5/21/63, 8/7/63, 8/11/63, 9/6/63, 10/8/63.
 - ② Due to indistinct nature of photo copies, no cards, ends on warrants dated 8/9/63 (address only as log. #10 & this has similar) & other submitted material submitted by SA airtel 8/29/63 8/26/63, 9/3/63, 9/13/63, 9/23/63 (a few were noted with KY + KS) and 10/11/63 (Kv. of sig ends both sub. with KY).
- ③ Ident Oswald sig on Texas + LA unemployment forms by Oswald, KY + KS except LA Form 10-2 dated 8/27/63 (too indistinct, but no sig seen) and LA Form 10-2 dated 9/3/63 (distorted but no sig seen).
- ④ Ident Oswald sig on two Texas Claim Cards, Forms 10-4 by Oswald.
- ⑤ Hand originals as clear photos of above mentioned forms which have not been identified.
