LETTER DATED MARCH TWENTY THREE LAST FROM THE PRESIDENT'S COMMISSION REQUESTS THE BUREAU TO FURNISH CERTAIN EXHIBITS PERTAINING TO THIRTY EIGHT SMITH AND WESSON REVOLVER SHIPPED TO A. J. HIBELL, DALLAS, TEXAS, MARCH TWENTY, NINETEEN SIXTY THREE. COMMISSION REQUESTS QUOTE A PAGE FROM THE LOOSE LEAF NOTEBOOK OF MICHAELIS ON WHICH IS ENTERED RECORD OF THIRTY EIGHT SMITH AND WESSON REVOLVER SHIPPED TO A. J. HIBELL, DALLAS, TEXAS, MARCH TWENTY, NINETEEN SIXTY THREE ENQUOTE. THIS ITEM REFERRED TO IN PAGE TWO THREE ONE OF REPORT OF SA ROBERT P. GENSERLING, DALLAS, DECEMBER TEN, NINETEEN SIXTY THREE APPARENTLY PREPARED FROM LOS ANGELES INSERT DATED DECEMBER TWO NINETEEN SIXTY THREE PREPARED BY SA W. JAMES WOOD.
