NOTE:

Commission letter 5-20-64, is very extensive in nature and requires considerable work on part of the Bureau. They have listed some 37 items of evidence which they feel needs to be displayed to the individual who first found the particular item and who can identify it by inspection. In discussion with Hr. Eisenberg of the Commission staff with SA Jevens en 5-22-64, it was aspertained that the Commission will permit photographic identification in place of transmitting all of the evidence now being retained in the laboratory to Dallas.

Lallas is in possession of plotographs of all items of evidence referred to above. It is pointed out some of the evidence was obtained here in Washington through lisicon and other sources, while some of the evidence was obtained by other field offices. In the instances where the material was obtained here at Washington, the Bureau will furnish the necessary information so it can be incorporated in a letterhead memorandum for dissemination to the Commission. This matter will be followed closely and when the results are obtained, the Commission will be notified.
