Page 39 of the transcript refers to the sig "Alek J. Hidell"  
on the counterfeit Selective Service System Notice of Classification,  
Commission Exhibit 795. It was concluded that the "Alek J. Hidell"  
signature on Comm Ex 795 was written by Lee Harvey Oswald  
based on <sup>comparison with</sup> Comm Ex 55, 56, 66, 778, 780, 781 and 788 & FBI Ex D4  
~~the use of~~

~~(Ladigan Ex 2 and 3) as known standards of the law  
of LHO.~~

Page 47 of the transcript refers to the rubber stamp bit,  
Comm Ex 115 and the rubber stamp impression on Oswald's  
vaccination certificate Comm Ex 813. As a result of  
a comparison of Comm Ex 115 and 813 it was concluded that  
~~that the impression~~ "NEW ORLEANS, LA." portion of  
the rubber stamp impression on Comm Ex 813 was made with the rubber stamp bit, Comm  
Ex 115. <sup>no conclusion could be reached with respect to</sup>  
The first two lines of the rubber stamp impression on  
Comm Ex 813 <sup>are</sup> not comparable with the rubber stamp setup
