LEE HARVEY / OSWALD /

On December 1, 1956, George M. Scott, Detective Investigator and Camerlin B. Posey, pre-police trainee of the San Antonio, Texas, Police Department, heard the following comments made by Mrs. MARGUERITE OSWALD, mother of deceased LEE HARVEY OSWALD, while she was waiting for an airplane at the International Airport, San Antonio, Texas:

On December 1, 1966, GEORGE M. SCOTT, Detective Investigator, San Antonio Texas, Police Department, who resides at 223 Coronet Lane, San Antonio, advised as follows:

When Mrs. MARGUERITE OSWALD came to San Antonio on a visit on November 29, 1966, pre-police trainee CAMERLIN B. POSEY and he were assigned the duty of observing Mrs. OSWALD during her stay and to be alert for any possible trouble. As far as he could ascertain, there were no incidents during her visit to San Antonio.

On December 1, 1966, during the time he was in Mrs. OSWALD's presence at the International Airport in San Antonio while she was awaiting her plane, she made the following remarks, which were unsolicited, which she said she could not make on the radio or television because she knew they would cut her off:

She stated that she has letters from Cuba and Russia stating that LYNDON JOHNSON was connected with the assassination of former President KENNEDY.

She also stated that President JOHNSON broke the law when he removed former President KENNEDY's body from the hospital without proper papers or autopsy by the coroner.

Mrs. OSWALD also stated that when President and Mrs. JOHNSON went before the Warren Commission to testify in connection with the assassination of former President KENNEDY, he was not placed under oath. On the other hand, such witnesses as JACQUELINE KENNEDY and J. EDGAR HOOVER were placed under oath when they testified. Mrs. OSWALD pointed out that this was done so that if President JOHNSON was not telling the truth, he could not be charged with perjury.

She also said that the President and his family do violate the law but they should be made to obey it like the

common people such as herself. She did not mention how she thought the President allegedly violated the law.

Mrs. OSWALD advised that the day her son was murdered, agents of the Secret Service had visited her home and took her and her daughter-in-law, MARINA OSWALD, to a town south of Fort Worth, Texas, for their own protection. SCOTT could not recall if she mentioned the name of the town. She stated that while they were driving in the car, a report came over the radio in the Secret Service car about her son, LEE HARVEY OSWALD. When she questioned the agents about this, they stated that he had been shot in the shoulder. She then asked to be taken to him, however, one of the Secret Service agents stated that such a move could endanger the life of MARINA OSWALD.

SCOTT advised that Mrs. OSWALD stated that if they could protect the life of JACKIE KENNEDY, she could not see why they could not afford protection to the mother and wife of a person like LEE HARVEY OSWALD. The Secret Service agents finally gave in, took them to the hospital, and stated that once they entered the hospital they could offer neither Mrs. MARGUERITE OSWALD nor the wife of LEE HARVEY OSWALD any further protection, that this would be up to the Texas State officials.

Mrs. MARGUERITE OSWALD was then led to her son who was dead on a slab in the hospital covered with the exception of his head. She learned that he had been shot in the stomach while handcuffed. She said that at this moment she got a message, she does not know from where, and she recalls shouting, "This boy has not killed anyone and someday the world will know."

SCOTT advised that he asked no questions of Mrs. MARGUERITE OSWALD since he was under instructions not to.

SCOTT advised that Mrs. OSWALD left San Antonio at approximately 11:00 a.m., December 1, 1965, on Flight 68 of Braniff Airlines en route to Ft. Worth, Texas.

On December 1, 1966, CAMERLIN B. POSEY, pre-police trainee for the San Antonio, Texas, Police Department, who resides at 147 Mink Street, San Antonio, advised as follows:

When Mrs. MARGUERITE OSWALD came to San Antonio for a visit on November 29, 1966, he and Detective Investigator GEORGE M. SCOTT, were assigned the duty of observing Mrs. OSWALD and were advised to be alert for any possible trouble. He stated that as far as trouble was concerned, her visit went off without any problems.

When POSEY accompanied Mrs. OSWALD to the airport in San Antonio at approximately 10:30 a.m., December 1, 1966, she was very talkative and in his presence made the following unsolicited remarks which he thought would be of interest to the FBI:

She advised that although she could not make these remarks on the radio or television, she thought that he would be interested in knowing. She stated that she has letters from Cuba and Russia stating that Lyndon Johnson was connected with the assassination of KENNEDY.

She also stated that when President and Mrs. JOHNSON were called before the Warren Commission to testify, that neither was placed under oath. However, when Mrs. JACQUELINE KENNEDY and J. EDGAR HOOVER were called to testify, they were placed under oath. She stated that this shows that if the President did not tell the truth, he could not be held on a charge of perjury.

Mrs. OSWALD also stated that the President and his family do violate the law, but they should not be allowed to do so, that they should be made to observe the law like common people such as herself. She did not state how she thought the President allegedly violated the law.

She advised that if an attempt had been made on her life while she was in San Antonio, the American people would not have stood for the murder of a son and his mother as the result of the same assassination. She said any attack on her would cause a furor throughout the United States.

She pointed to a man at the counter of Braniff Airlines in San Antonio, and stated that he follows her wherever she goes. She said he always travels first class and she referred to him as a "FED". She offered no further explanation of her remarks. POSEY advised that they did not check the man since they had specific instructions to observe and make no inquiries or investigations unless there was an incident. POSEY advised that this unidentified person did enter the plane which Mrs. OSWALD boarded in San Antonio, and he did enter the first class cabin section of the plane.

POSEY described this unidentified male as follows:

POSEY advised that he did not observe the man pay any attention whatsoever to Mrs. OSWALD.

Mrs. OSWALD also remarked that fifteen persons connected with her, her son LEE HARVEY OSWALD or JACK RUBY prior to or about the time of the assassination of KENNEDY had been killed. She stated that the most recent person

was an individual who owned a night club in Dallas. He was dead a week before the police found him. He was a friend of RUBY's.

She continued by stating that the taxi driver who had taken her son LEE HARVEY OSWALD across town following the assassination attempt on the life of President KENNEDY, was killed later in a collision. She stated that his passenger was an important Government employee from Washington, D. C. He was not injured and just disappeared following the accident. She thought this was very peculiar.

She never did state who the fifteen persons were nor their relation to the case except the owner of the club and the taxi driver.

Mrs. OSWALD advised that the day her son was murdered, the Secret Service came to her home and told her that they were taking her and her daughter-in-law, MARINA OSWALD, then wife of LEE HARVEY OSWALD, to a small town south of Ft. Worth, Texas, for their own protection. While riding in the Secret Service car a notice came across the two-way radio about LEE HARVEY OSWALD being shot. The agent driving the car took the receiver and told the person on the radio not to repeat the news. When she inquired as to what had happened, she was informed that her son had been shot in the shoulder. She looked at the Secret Service agent for a moment, then got a feeling and said to the agent, "My son has expired." The agent did not give her a straight answer. She insisted that she be taken to the hospital where her son was. The Secret Service agent said that any such move would endanger the life of MARINA OSWALD.

Mrs. OSWALD said that she told the Secret Service agents that she thought it funny they could protect JACKIE KENNEDY with no trouble, yet they could not protect a mother who wanted to see her own son accompanied by his wife. After a short discussion, the Secret Service agents gave in and took her to the hospital where her son had been taken.

Upon arriving at the hospital the Secret Service agents told her that once she entered the hospital they could afford her no protection, and that it would be up to the Texas State officials to take over.

Mrs. MARGUERITE OSWALD, accompanied by her daughter-in-law, went into the hospital and were taken to the room where her son lay dead. He was on a slab completely covered with the exception of his face. She looked at his face and turned to the attendants and said he had been crying and they agreed. She then said she got a message, she does not know from where, and she recalls shouting, "This boy has not killed anyone and someday the world will know."

POSEY advised that Mrs. MARGUERITE OSWALD boarded Braniff Flight 68 en route to Ft. Worth, Texas, at approximately 11:00 a.m., December 2, 1966.

On December 1, 1966, GUY HARRIS, General Manager of San Antonio Radio Station WOAI where Mrs. MARGUERITE OSWALD appeared as a guest, advised POSEY that Mrs. OSWALD told him that the FBI and Secret Service opens her mail and because of this she does not get all of her mail.

HARRIS stated that he challenged her on this point, stating that he felt certain that neither the FBI nor the Secret Service open her mail. She said that they must use "X-ray" and after reading it take the mail they don't want her to get.
