GARY CULVER TO TRACEY F. SCHOLTZ, UTICA, MICH. THIS TELEGRAM
SENT THREE ZERO SEVEN PM, SEATTLE TIME, ON NOV. TWENTYTHREE BY
GARY E. CULVER, ATTORNEY, HOGE BLDG.

NR CULVER SE INDICES, SEATTLE PD OR KING COUNTY SO. CULVER
IS MEMBER WELL KNOWN LAW FIRM INCLUDING FORMER AUSA MURRY B. GUTERSON.
CULVER APPEARED SE OFFICE THIS AM TO EXPLAIN TELEGRAM WAS JOKE TO
HARRASS FORMER CLASSMATE TRACEY SCHOLTZ. HE DESCRIBES AS ULTRA
CONSERVATIVE AND POLITICALLY OPPOSED TO KENNEDY BROTHERS. CLAIMS
SCHOLTZ ALSO RABID TV FAN AND WOULD BE UPSET ON EXCLUSIVE TO
COVERAGE KENNEDY STORY TO EXCLUSION OF NFL FOOTBALL GAME OF WEEK.
CULVER ADVISES HE IS PRO KENNEDY AND REGRETS SENDING TELEGRAM.
NO FURTHER INVESTIGATION THIS INCIDENT UACB OR DALLAS.
