RALPH DELANEY HUGHES LOCATED TODAY AT PARENTS HOME, ROUTE ONE, ROAN MOUNTAIN, TENN., WAS INTERVIEWED UNDER ADVERSE CIRCUMSTANCES DUE TO OBVIOUS MENTAL DISTURBANCE. HUGHES STATED CLIFFORD AND MARY ELDRIDGE RAPHEN PH PAREN, NEIGHBORS IN YOUNGSTOWN, OHIO, DROVE HIM AND HIS FAMILY TO HIS PARENTS HOME, NOV. SIXTEEN LAST. HE STATED ELDRIDGES PROBABLY KNOWN TO RAY CARLYLE, MANAGER, SHERVIN WILLIAMS PAINT CO., HUBBARD, OHIO, HUGHES FORMER EMPLOYER.

HUGHES MOTHER, MRS. TOM HUGHES, ADVISED THAT HER SON RALPH AND HIS FAMILY WERE BROUGHT HOME BY A MR. AND MRS. ELDRIDGE OF YOUNGSTOWN, OHIO, ON NOV. SIXTEEN LAST WHERE HE WAS REMAINED SINCE. SHE EXPLAINED THAT HER SON SINCE TWELVE YEARS OF AGE, HAS HAD MENTAL DISTURBANCES PERIODICALLY, NECESSITATING PROLONGED TREATMENT. SHE STATED SHE FURNISHED ERRONEOUS INFORMATION TO RAY CARLYLE WHO CONTACTED HER RECENTLY
