RE COMMENTS OF REVEREND CARL MC INTYRE REGARDING
PRESIDENT KENNEDY DASH MISCELLANEOUS.

REVEREND CARL MC INTYRE, COLLINGSWOOD, N.J.,
CONDUCTS RADIO PROGRAM CALLED THE TWENTYIETH CENTURY
REFORMATION HOUR AND IS WELL KNOWN TO THE BUREAU. HE IS
A CONTROVERSIAL FIGURES. MC INTYRE IS THE ORGANIZER OF THE
AMERICAN COUNCIL OF CHRISTIAN CHURCHES AND HAS BEEN AN
OUTSPOKEN FOE OF THE NATIONAL COUNCIL OF CHURCHES OF CHRIST.
HE HAS STATED PUBLICLY THAT THE COMMUNISTS ARE USING THIS LATTER
GROUP IN THE UNITED STATES. THE REVEREND MC INTYRE WAS NOT
LOCATED FOR INTERVIEW UNTIL ELEVEN TWENTY NINE SIXTY THREE
AS HE WAS OUT OF TOWN AND UNAVAILABLE.

MC INTYRE ADVISED THAT ALL OF HIS SUNDAY SERMONS IN COLLINGSWOOD, N. J., ARE BROADCAST LOCALLY AND SENT OUT ALL OVER THE UNITED STATES FOR REBROADCAST BY LOCAL STATIONS. MC INTYRE ADVISED THAT HE RECENTLY DID RECORD A RADIO BROADCAST WHICH WAS UTILIZED IN THE MIDWEST ON THE TWENTIETH CENTURY REFORMATION HOUR RELATIVE TO A CONFERENCE OF THE NATIONAL COUNCIL OF CHURCHES OF CHRIST TO BE HELD IN PHILADELPHIA, PA., TWELVE THREE NEXT. MC INTYRE ADVISED THAT HE HAD OPPOSED THE PLANNED APPEARANCE OF PRESIDENT KENNEDY SPEAKING BEFORE THIS GROUP AS BEING IN CONFLICT WITH THE PRINCIPAL OF SEPARATION OF CHURCH AND STATE. MC INTYRE ADVISED THAT HE HAD SENT A LETTER TO PRESIDENT KENNEDY OBJECTING TO THE PRESIDENT-S APPEARANCE AT THE ABOVE CONFERENCE ON TWELVE THREE NEXT. MC INTYRE ADVISED THAT HIS REMARKS IN THE BROADCAST IN QUESTION RELATIVE TO SOMETHING HAPPENING TO PREVENT PRESIDENT KENNEDY FROM ATTENDING THE MEETING WERE SAID IN THE HOPE THAT THE PRESIDENT AS THE RESULT OF THE LETTER SENT TO HIM BY MC INTYRE WOULD REALIZE THAT HIS ATTENDANCE AT THE AFFAIR

HAS IN CONFLICT WITH THE SEPARATION OF CHURCH AND STATE

SADDENED OVER THE DEATH OF PRESIDENT KENNEDY AND THAT A

HALL IN OPPOSITION TO THE CONFERENCE OF NATIONAL COUNCIL
OF CHURCHES OF CHRIST HAS BEEN CANCELLED BY HIM.
