RE BUREAU TEL CALL FROM W. A. ERANIGAN, DIVISION FIVE,

[RE CARLOS TUIROGA.] /S IN TUIROGA UNDERSCORED/

ON ELEVEN TWENTYSEVEN INSTANT, SA JOHN T. REYNOLDS CONTACTED [CARLOS TUIROGA], RESIDING THREE ONE THREE FOUR DEPTY PLACE. HE FURNISHED THE FOLLOWING INFORMATION ON A STRICTLY CONFIDENTIAL BASIS, INASMUCH AS HIS FATHER IS IMPRISONED IN CUBA AND HIS MOTHER STILL LIVES THERE.

HE IS ACQUAINTED WITH CARLOS BRINGUIER, CUBAN STUDENT DIRECTORATE, NEW ORLEANS, AND WAS AWARE OF THE ARREST OF BRINGUIER AND TWO OTHER CUBANS ALONG WITH LEE HARVEY OSWALD ON EIGHT NINE LAST WHEN OSWALD PASSED OUT FAIR PLAY FOR CUBA /FPCC/ HANDILLS ON CANAL STREET. APPROXIMATELY A WEEK LATER / EIGHT SIXTEEN LAST/ HE WAS SEATED IN THOMPSON/S RESTAURANT WHEN REPRESENTATIVE OF PUERTO RICO, WHO HAS OFFICE IN INTERNATIONAL TRADE MART, SHOWED HIM FPCC HANDEILL, END PAGE ONE

TELLING [QUIROGA] THESE HANDBILLS WERE BEING PASSED OUT IN FRONT OF INTERNATIONAL TRADE MART. [QUIROGA] NOTIFIED POLICE, BUT POLICE ARRIVED TOO LATE, AND PERSON PASSING OUT HANDBILLS HAD GONE.

IN ORDER TO OBTAIN INFORMATION REGARDING FPCC TO TURN OVER TO AUTHORITIES, HE DROVE TO ADDRESS LISTED ON HANDBILL FOR OSWALD, AND LOCATED RESIDENCE FOUR NINE ZERO SEVEN MAGAZINE STREET. IN ORDER TO LOCATE THE ACTUAL APARTMENT OF OSWALD, HE HAD TO MAKE INQUIRY AT FOUR NINE ZERO SEVEN MAGAZINE AND LEARNED THE EXACT LOCATION OF THE APARTMENT. AT FOUR NINE ZERO FIVE MAGAZINE ST. AS HE STARTED TO ENTER THE YARD, OSWALD STOOD SOME DISTANCE FROM HIM AND SAID QUOTE DON'T HIT ME. IF YOU'RE COMING AS A FRIEND, COME IN. UNQUOTE. OSWALD HAD BEEN SITTING ON HIS FRONT PORCH AND WAS TALKING IN ANOTHER LANGUAGE TO SOMEONE INSIDE. HE TOLD OSWALD THAT HE HAD

PICKED UP LEAFLET AT THE INTERNATIONAL TRADE MART, THAT HE WAS A CUBAN WHO HAD BEEN IN THE UNITED STATES FOR A LONG TIME AND WAS INTERESTED IN LEARNING ABOUT THE FPCC.

[QUIROGA] TOLD OSWALD THAT HE KNEW ABOUT THE CUBANS BEING ARRESTED WITH OSWALD, AND THAT HE DID NOT THINK IT WAS RIGHT THAT THOSE PERSONS SHOULD HAVE BEEN FREED WHEN OSWALD WAS HELD. OSWALD INFORMED HIM THAT THE CUBANS IN THE UNITED STATES WERE ALL CRIMINALS, AND SATCASTICALLY SAID THAT QUOTE WE HAVE MINE LAWS HERE UNQUOTE. HE SAID THAT FIDEL CASTRO WAS NOT A DICTATOR, AND THAT IF THE US WOULD INVADDE CUBA, HE WOULD FIGHT WITH FIDEL CASTRO AGAINST THE US. HE STATED FURTHER THAT THE PRESS IN THE US IS AGAINST THEM / NOT IDENTIFYING THEM /, THAT THEY WERE IN THE MINORITY TODAY BUT ONE DAY WOULD BE THE MAJORITY AND THEN ALL THE PRESS WOULD BE WITH THEM. OSWALD CLAIMED TO BE A STUDENT OF LANGUAGES AT TULANE UNIVERSITY AND TO BE THE DELEGATE FOR THE

DELEGATE FOR THE FPC IN NEW ORLEANS. HE CLAIMED THAT HE WAS CONDUCTING PRIVATE MEETINGS AND WOULD BE PRONE TO HAVE [QUIROGA] TO JOIN THEM. HE DID NOT IDENTIFY THE PLACE OF THE MEETING OR ANY OTHER ALLEGED MEMBERS OF FPCG.

[QUIROGA] INFORMED HIM THAT HE WAS INTERESTED IN THE ORGANIZATION BUT WOULD LIKE TO READ SOME LITERATURE BEFORE DECIDING. OSWALD GAVE HIM A BROCHURE QUOTE THE CRIME AGAINST CUBA UNQUOTE BY COPLISS LAHONT AND AN APPLICATION TO JOIN THE FPCG, NEW ORLEANS. THIS APPLICATION DID NOT SHOW ANY ADDRESS FOR THE COMMITTEE BUT SHOWED THAT THE INITIAL FEE IS ONE DOLLAR, THE DUES ARE ONE DOLLAR A MONTH, AND FOR A PERSON NOT ABLE TO PARTICIPATE AS AN ACTIVE MEMBER, BUT WISHING TO SUBSCRIBE TO MAILINGS, THE FEE WAS FIVE DOLLARS FOR ONE YEAR.

[QUIROGA] ON CONCLUSION OF TALK WITH OSWALD INFORMED

LIEUTENANT FRANK MARTELLO, FIRST DISTRICT, NEW ORLEANS
POLICE DEPARTMENT, REGARDING HIS CONTACT WITH OSWALD
AND TOLD HIM HE WOULD BE WILLING TO FILL OUT APPLICATION
AND REPORT ANY INFORMATION OBTAINED TO MARTELLO IN EFFORT
TO DO AWAY WITH EDGE IN NEW ORLEANS. SAID HE RECEIVED
NO ENCOURAGEMENT FROM MARTELLO AND TOOK NO FURTHER ACTION.

[QUIPOGA] HAD NO FURTHER CONTACT WITH OSWALD AND
DOES NOT KNOW OF ANYONE NAMED HIRSH, JACK LEON RUBY, JACK
TUBENSTEIN, AND KNOWS NOTHING FURTHER ABOUT ANY FPCC IN NEW ORLEANS.

[QUIPOGA] ADVISED WHEN HE WENT TO SEE OSWALD HE
WAS DRIVING HIS NINETEEN FIFTYEIGHT RED AND WHITE
CHEVROLET SEDAN WHICH HE PARKED IN FRONT OF FOUR NINE
NAUGHT SEVEN MAGAZINE STREET. [QUIPOGA] IS DESCRIBED AS A
WHITE MALE, BORN JANUARY TWENTYSEVEN NINETEEN THIRTYSIX
HAVANA, CUBA / HEIGHT FIVE FEET NINE AND ONE HALF, WEIGHT
ONE HUNDRED FORTYFOUR LBS, BUILD SLENDER, HAIR BLACK,
EYES BROWN, COMPLEXION MEDIUM. DOES NOT WEAR GLASSES.
WAS DRESSED IN DUNGH DASH GRAY SUIT AND WORE NO HAT.

CARLOS BRINGUIER, CUBAN STUDENT DIRECTORATE,
OPERATOR OF CACA BOCA CLOTHING STORE, ONE ZERO SEVEN
DECATUR STREET, ADVISED SA JOHN T. REYNOLDS THAT ON
AUGUST FIVE LAST OSWALD CAME INTO HIS STORE AND GAVE
HIM A MAPINE GUIDE BOOK, STATING HE WAS AN EXMARINE WHO
COULD FIGHT AGAINST CASTRO AND IF NEEDED, COULD HELP
TRAIN CUERRILLAS. HE PUT HIS HAND IN HIS POCKET AS
IF TO CONTRIBUTE MONEY TO THE CUBAN STUDENT DIRECTORATE
BUT BRINGUIER STOPPED HIM AND TOLD HIM HE COULD NOT ACCEPT
CONTRIBUTIONS AND THAT HE WAS ONLY MEMBER OF DIRECTORATE
IN NEW ORLEANS. OSWALD TOLD HIM NOT TO LIE ABOUT IT/
THAT QUOTE HE UNQUOTE CAN INFILTRATE YOU, AT WHICH TIME
BRINGUIER BECAME SUSPICIOUS OF OSWALD AND WOULD TALK NO
MORE WITH HIM. SAW OSWALD ON AUGUST NINE LAST WHEN
OSWALD WAS ARRESTED AFTER OSWALD TRIED TO DISTRIBUTE
FPCC HANDFULS ON CANAL STREET. BRINGUIER AGAIN SAW
OSWALD AT OSWALD'S TRIAL IN MUNICIPAL COURT AUGUST
TWELVE LAST AND THEN SAW HIM AT SIX PM AUGUST TWENTYONE
LAST AT THE DEBATE IN WHICH OSWALD PARTICIPATED OVER
RADIO STATION WDSU IN NEW ORLEANS. CLAIMS HE HAS NO
