INFORMANT

LEONARD G. WIDNER, TWO THREE ZERO TWO HANOVER AVE., N.W.,

ROANOKE, VA., BARBER AT CAVE SPRING BARBER SHOP, ROANOKE, VA.,

ADVISED THAT ON NOVEMBER TWENTYFIVE, SIXTYTHREE, BETWEEN TEN FIFTEEN A. M. AND TEN FORTYFIVE A. M., AN UNKNOWN WHITE MALE, EARLY FORTIES, FIVE TEN TO FIVE ELEVEN, TWO HUNDRED LBS., HUSKY BUILD, MEDIUM BLOND HAIR, THINNING ON TOP, BLUE-GREY EYES, HAD A HAIRCUT.

WHILE IN THE SHOP HE STATED THAT TWO WEEKS AGO HE WAS AT A CONVENTION AT CHICAGO, ILL., NATURE OF WHICH NOT STATED, WHICH WAS ATTENDED BY ONE OR MORE UNKNOWN DALLAS, TEXAS CITY COUNCILMEN. ONE COUNCILMAN STATED THAT PRESIDENT KENNEDY WAS GOING TO DALLAS, BUT HE, THE PRESIDENT, WOULD NOT KNOW WHEN HE

THAT APPROXIMATELY ONE MONTH AGO [REDACTED] LONNIE MORGAN
OUTSIDE BILLIE/S CAFE, RYAN ST., LAKE CHARLES. HE AND
MORGAN WERE ALONE AT THE TIME. MORGAN STATED QUOTE I AM
RAISING SOME MONEY TO GET RID OF THAT SOB. UNQUOTE. [REDACTED]
ASKED HIM WHAT HE MEANT AND MORGAN REPLIED QUOTE KENNEDY. UNQUOTE.
MORGAN THEN DISPLAYED A SMALL PIECE OF NOTE PAPER WITH
WHAT APPEARED TO BE HANDWRITTEN NAMES THEREON AND WRAPPED
THE NOTE PAPER AROUND SOME CURRENCY, DENOMINATIONS UNKNOWN.
HE WAS UNABLE TO READ THE NAMES ON THE PAPER OR THE NUMBER
OF NAMES. [REDACTED] ASSUMED THE CURRENCY REPRESENTED PREVIOUS
CONTRIBUTIONS. AT THIS POINT THE CONVERSATION WAS TERMINATED BY THE
ARRIVAL OF ONE OR TWO OTHER MEN, IDENTITIES NOT
RECALLED. MORGAN DID NOT MENTION THE NAME OF ANY GROUP
OR ORGANIZATION HE MIGHT HAVE BEEN REPRESENTING [REDACTED]
SAYS MORGAN MAY HAVE BEEN USING THIS APPROACH IN EFFORT TO MAKE
PERSONAL
LOAN FROM HIM. HE HAS HAD NO FURTHER DISCUSSIONS IN SUBSEQUENT
CONTACTS WITH MORGAN CONCERNING THIS MATTER.

[REDACTED] DID NOT BELIEVE AT THAT TIME MORGAN ACTUALLY MEANT THE
DEATH OR
PHYSICAL HARM TO THE PRESIDENT WHEN HE USED THE PHRASE
QUOTE GET RID OF THE SOB UNQUOTE BUT FOLLOWING THE ASSASSINATION,
