DURING PM NOVEMBER TWENTY FIVE, LAST E.R. ADAMS, ONE ONE NINE SHOTOKA, WAYNE, MICHIGAN, /REQUESTED IDENTITY BE PROTECTED ADVISED HE WAS WORKING IN DALLAS, TEXAS, FOR TWO WEEKS IN EARLY JUNE, SIXTY THREE. ADAMS STATED HE STOPPED INTO THE PATIO LOUNGE, BAR LOCATED ON ONE WAY MAIN STREET IN DALLAS, WHERE HE MET STRANGER ONE EVENING. HE BELIEVES THE PATIO LOUNGE WITHIN COUPLE OF BLOCKS OF AREA OF STRIP DASH JOINTS ALLEGEDLY OWNED BY JACK RUBY. ADAMS STATED THIS INDIVIDUAL CLAIMED TO BE IN THE EXPORT DASH IMPORT BUSINESS AND HAD AN OFFICE IN THE SAME BLOCK AS THE PATIO LOUNGE. THIS NAME UNKNOWN, HAD JUST RETURNED FROM OVERSEAS.

[ADAMS] STATED THIS INDIVIDUAL WAS WELL DRESSED AND SEEMED WELL EDUCATED. ADAMS DESCRIBED THIS INDIVIDUAL AS BEING WHITE, AMERICAN, ABOUT FORTY FOUR TO FORTY SIX YEARS OF AGE

SIX FEET TALL, ONE HUNDRED EIGHTY POUNDS, BLACK HAIR, AND SOMEWHAT RESEMBLED TEXAS GOVERNOR CONNALLY, HOWEVER, DEFINITE WAS NOT GOVERNOR CONNALLY. ADAMS STATED THE ABOVE DESCRIBED INDIVIDUAL QUOTE PICKED UP UNQUOTE TWO WOMEN IN THE BAR AT THE PATIO LOUNGE AND THE FOUR OF THEM SPENT THE EVENING TOGETHER. HE STATED THAT BOTH OF THE WOMEN WERE EMPLOYED IN THE ADVERTISING DEPARTMENT OF ONE OF THE DALLAS NEWSPAPERS., THAT THEY ACCEPTED ADS OVER THE TELEPHONE AND THAT THEY USUALLY ASSUMED A CODE NAME IN THEIR WORK SELECTING THE NAME OF SOME TEXAS CITY. ADAMS STATED HE RECALLS THAT ONE OF THE WOMEN USED THE NAME QUOTE MRS. AUSTIN UNQUOTE.

ADAMS ADVISED THAT THE ABOVE DESCRIBED MALE WHO APPEARED TO BE SOBER DURING THE COURSE OF THE EVENING MADE ANGRY AND HIGHLY INFLAMMATORY STATEMENTS AGAINST PRESIDENT KENNEDY.

ADAMS STATED THIS INDIVIDUAL CLAIMED TO HAVE MADE SEVERAL TRIPS TO WASHINGTON, D.C. TO SEE PRESIDENT KENNEDY BUT WAS NEVER SUCCESSFUL IN HIS ATTEMPT TO SEE KENNEDY. ADAMS ADVISED THAT THIS INDIVIDUAL CLAIMED THAT HE QUOTE HAD ENOUGH ON PRESIDENT KENNEDY TO IMPEACH HIM UNQUOTE. [ADAMS] RECALLED END PAGE TWO

THAT DURING THE EVENING HE WAS WITH THIS INDIVIDUAL IN THE PATIO LOUNGE THIS INDIVIDUAL MADE A STATEMENT TO THE EFFECT.

THAT QUOTE YOU CAN COUNT ON ONE THING FOR SURE. IF PRESIDENT KENNEDY EVER COMES TO DALLAS HE WILL BE ASSASSINATED UNQUOTE.
