LOS ANGELES REQUESTED BIRMINGHAM TO ACCOUNT FOR LYNCHS WHEREABOUTS DURING PERTINENT PERIOD REGARDING CAPTIONED MATTER SINCE LYNCH REPORTED TO HAVE BEEN OUTSPOKEN AND OPINION ABOUT RACIAL SITUATION AT NSRP MEETING IN CALIFORNIA.

BIRMINGHAM FILES AND [REDACTED] REFLECT LYNCH, AKA. CONRAD LYNCH, HAD BEEN IN BIRMINGHAM AREA APPROXIMATELY TWO TO THREE MONTHS TO ASSIST DR. E. R. FIELDS.
