RECORDS HARRIS COUNTY SO REFLECT SUBJECT JOE NOBLE ADAMS, DOB FEBRUARY FOUR, TWENTYNINE, AT HOUSTON, TEXAS, WAS ARRESTED FEB, THREE, FIFTYEIGHT, ON CHARGE OF WORTHLESS CHECKS. CASE DISMISSED MARCH SIX, SIXTYONE.

RECORDS DISTRICT CLERK/S OFFICE, HARRIS COUNTY, TEXAS REVEALED JOSEPH N. ADAMS AND JAMES E. DOBBINS WERE CHARGED WITH A COMPLAINT ON OR ABOUT MAY FIFTEEN, FORTYEIGHT, FOR FRAUDULENTLY TAKING THREE TYPEWRITERS AND ONE ADDING MACHINE, TOTAL VALUE TWO HUNDRED FIFTY DOLLARS, JOSEPH N. ADAMS WAIVED TRIAL AND PLED GUILTY.

RECORDS HOUSTON PD REFLECT THAT JOSEPH N. ADAMS, AKA., JOE D. ADAMS, ARRESTED HOUSTON, TEXAS, AUG. NINETEEN, FORTYEIGHT FOR FELONY THEFT. RESULT TWO YEARS PROBATION. NUMEROUS OTHER ARRESTS MADE FROM FORTYNINE THROUGH FIFTYNINE WHICH WERE RELEASED OR NO DISPOSITION AVAILABLE.
