ASSASSINATION OF PRESIDENT JOHN F. KENNEDY, NOV. TWENTYTWO LAST, DALLAS, TEXAS. RE UNKNOWN INDIVIDUAL INQUIRING ABOUT SILENCER AT DALLAS NOV. TWENTYTWO LAST DASH MISCELLANEOUS.

FOLLOWING BY SA WILLIAM H. BUCKLER

LOVELL CHISUM, HILLSBORO, TEXAS, STATES AT ABOUT SEVEN A.M., NOV. TWENTYTWO LAST, HE STOPPED AT SERVICE STATION DALLAS, TEXAS, AND ASKED ATTENDANT FOR DIRECTIONS TO LOVE FIELD. BEFORE ATTENDANT COULD ANSWER, UNSUB WHO WAS IN STATION ASKED CHISUM /DO YOU KNOW WHERE I CAN GET A SILENCER FOR A HIGH POWERED GUN/ CHISUM STATES UNSUB SAW THAT CHISUM WAS SURPRISED BY QUESTION AND THEN LEFT. ATTENDANT GAVE CHISUM DIRECTIONS AND UNSUB LEFT STATION AT ABOUT SAME TIME AS CHISUM. UNSUB SEEN DRIVING AWAY IN TWO TONE, COLOR UNKNWON, FIFTYSEVEN CHEVROLET, LICENSE UNKNWON. NAME OF OIL COMPANY AND ATTENDANT UNKNWON TO CHISUM WHO WAS TRAVELING SOUTH ON FREEWAY NO. SEVENTYSEVEN FROM GRAPEVINE.
