ASSASSINATION OF PRESIDENT JOHN F. KENNEDY, DALLAS, TEXAS  
NOVEMBER TWENTYTWO LAST.

WILLIAM RAY DOBKINS, WHITE MALE, TWENTYSIX YEARS, BORN JANUARY  
SIXTEEN, THIRTY-SEVEN, MC CAMEY, TEXAS, RESIDING THREE ZERO SEVEN  
SOUTH DORRIS STREET, MONAHANS, TEXAS, ARRESTED NOVEMBER TWENTY-NINE  
BY ODESSA, TEXAS POLICE AFTER WALKING INTO POLICE STATION CLAIMING  
QUOTE I AM ONE OF THE ONES THAT SHOT KENNEDY END QUOTE. DOBKINS  
PLACED IN JAIL ON DRUNK CHARGE.

DOBKINS INTERVIEWED TODAY BY SA ROY C. DAHL AT ODESSA. DOBKINS  
ADMITTED HE HAD BEEN DRINKING HEAVILY AND BEFORE GOING TO POLICE STATIO  
WENT TO TEXAS CAFE AND ATTEMPTED TO GET INTO REAR DOOR AND TOLD CAFE  
PEOPLE HE WAS INVESTIGATING OSWALD. DOBKINS WAS NOT ALLOWED TO ENTER  
SO WENT TO POLICE WHERE ARRESTED. DOBKINS ADMITTED MAKING STATEMENTS  
BECAUSE OF DRINKING AND WAS NOT REALLY INVOLVED IN ANY WAY.

WHEREABOUTS OF DOBKINS AT FATHERS BAKERY IN MINAHANS DURING  
SHOOTING AND FOLLOWING EVENTS VERIFIED. DOBKINS NOT IN VICINITY OF  
DALLAS ANYTINE DURING PERTINENT PERIOD AND HAD NO ACTUAL KNOWLEDGE  
OF SHOOTING.
