URGENT 12-2-63 GTAWOXXX 5-29 AM THK  
TO DIRECTOR, AND SAC-S CLEVELAND AND DALLAS  
FROM SAC CINCINNATI

ASSASSINATION OF PRESIDENT JOHN F. KENNEDY, NOVEMBER  
TWENTYTWO, SIXTYTHREE, DALLAS, TEXAS, OO DALLAS

FRANK JOSEPH SCHROETER TELEPHONICALLY ADVISED THIS OFFICE,  
AT APPROXIMATELY TWO THIRTY AM, DECEMBER TWO SIXTYTHREE, THAT HE  
WAS CONNECTED WITH THE BIGGEST SMUGGLEING GAME AROUND. AFTER  
FURTHER CONVERSATION HE ADVISED THAT HE KNEW WHO SHOT PRESIDENT  
JOHN F. KENNEDY AND THAT THE PERSON WAS PAID TWENTYFIVE THOUSAND  
DOLLARS.

SCHROETER ADVISED THAT HE WAS STAYING AT THE HIGHWAY MOTEL,  
MARION, OHIO, AND ADVISED THAT HIS LIFE WAS IN DANGER, AND COULD  
GIVE NO FURTHER INFORMATION OVER THE PHONE.

AT APPROXIMATELY FOUR AM DECEMBER TWO SIXTYTHREE, MARION  
OHIO POLICE ADVISED THAT SCHROETER HAD CALLED THEM AND DEMANDED  
THEY HOLD HIM FOR PROTECTION. THEY ADVISED THAT THEY WERE GOING  
TO HOLD HIM FOR PROTECTION AT MARION OHIO SHERIFF OFFICE TONIGHT,  
BUT ADVISED HE MAY BE MENTALLY DISTURBED.

CLEVELAND CONDUCT APPROPRIATE INVESTIGATION.
