REVEREND MAURICE DAWKINS, PEOPLE-S INDEPENDENT CHURCH

OF CHRIST, ONE ZERO TWO FIVE EAST EIGHTEENTH STREET, LOS

ANGELES, ADVISED TODAY THAT HE HAD RECEIVED A LETTER ON

OCTOBER TWENTYFOUR LAST FROM ANNIE L. WARREN, EMBASSY HOTEL,

ROOM SIX ONE SIX, STATING THAT SHE HAD ATTENDED A MEETING OF

THE QUOTE WINGS OF HEALING, WORLD CRISIS CONFERENCE UNQUOTE

SOMETIME DURING THE WEEK OF OCTOBER THIRTEEN NINETEEN LAST

THROUGH OCTOBER TWENTYFOUR LAST. SHE STATED A MAN WAS

INTRIDUCED AT THIS MEETING BY THE REVEREND DALE YOUNG. YOUNG

DID NOT GIVE THE MAN-S NAME BUT DESCRIBED HIM AS A QUOTE

YOUNG MAN THAT HAD SOMETHING TO DO UNQUOTE AND THAT THEY SHOULD

PRAY FOR HIM. WARREN-S LETTER SAID SHE TURNED TO THE WOMAN

NEXT TO HER AT THE MEETING AND SAID, QUOTE HE PAREN THE MAN

INTRODUCED END *WARREN DOESN'T LOOK RIGHT DASH SUPPOSE HE WANTS*

TO KILL THE PRESIDENT INQUOTE.

WARREN FURTHER STATED IN THE LETTER THAT ONE OF THE WOMEN WHO ATTENDS THESE MEETINGS NAMED MARY ORR, WHO ALSO RESIDES AT THE EMBASSY HOTEL, STATED IN A RECENT CONVERSATION THAT QUOTE I THINK THE PRESIDENT OUGHT TO BE SHOT UNQUOTE. HER LETTER FURTHER STATED THAT SHE THINKS WHAT THE RUSSIANS ARE SAYING IS EXACTLY RIGHT, THAT OSWALD IS A RACIST, KU KLUX KLANSMAN, AND ADDED, QUOTE I BELIEVE THE KILLERS OF THE PRESIDENT WERE PAID BY THE QUOTE RIGHT WING UNQUOTE WHICH IS A DISGUISED NAME FOR THE KU KLUX KLAN UNQUOTE.

WARREN ADVISED BUREAU AGENTS TODAY THAT THE MAN SHE SAW INTRODUCED BY REVEREND DALE YOUNG APPEARED TO RESEMBLE OSWALD. ADDITIONAL INFORMATION FURNISHED BY HER WAS SUBSTANTIALLY THE SAME AS THAT APPEARING IN THE LETTER TO DAWKINS. WARREN STATED SHE IS SIXTYFOUR YEARS OLD. SHE WAS MOVED TO TEARS DURING THE INTERVIEW WITH AGENTS, AND AGENTS QUESTION THAT SHE IS COMPLETELY RATIONAL.

OSWALD WAS PRESENT, NO ANYONE RESEMBLING HIM.

MRS. WYATT HAS BEEN INTERVIEWED BY CITY NEWS SERVICE
AND DENIED THAT OSWALD ATTENDED THE WORLD CRISIS CONFERENCE.
THIS MAY ALSO APPEAR ON THE WIRE SERVICES.
