ASSASSINATION OF PRESIDENT JOHN F. KENNEDY NOVEMBER TWENTY TWO  
LAST, DALLAS TEXAS.

RE NY TELETYPE TO RECEIVING OFFICES TWENTY THIRD INSTANT, <sup>N.Y.</sup> LA. 1  
SPECIFICALLY WHERE JAMES F. RIZZUTO ALLEGED THAT BOTH YVES LEANDEZ  
AND LEE H. OSWALD WORKED AT ONE TIME FOR AN FNU REGAN FROM MEMPHIS,  
TENN. AND THAT LEANDEZ STAYED WITH REGAN FOR SHORT PERIOD AT ROOSEVE  
HOTEL IN EARLY NINETEEN SIXTY ONE. THERE IS NO ROOSEVELT HOTEL IN  
MEMPHIS, BUT A ROOSEVELT HOTEL IS LOCATED IN NEW ORLEANS, LA. INVE  
GATION TO DATE FAILS TO IDENTIFY ANY REGAN POSSIELY IDENTICAL WITH  
REGAN REFERRED TO BY RIZZUTO. BELIEVED RIZZUTO MAY HAVE MEANT NEW  
ORLEANS.

NEW ORLEANS DIVISION REQUESTED TO CHECK RECORDS ROOSEVELT HOTEL  
IN EFFORT TO IDENTIFY REGAN AND TO CHECK OTHER LOGICAL SOURCES.

NEW YORK REQUESTED TO RE INTERVIEW RIZZUTO AND CLARIFY IN SPEC  
DETAIL HIS INFORMATION AS TO WHEN, WHERE AND UNDER WHAT CIRCUMSTANC  
LEANDEZ AND OSWALD WORKED FOR FNU REGAN. ADVISE MEMPHIS AND NEW OR  
IN ORDER THAT REGAN MAY BE IDENTIFIED AND LOCATED.
