Dear Mr. Hoover:

Although my thoughts may have no merits for you, I submit this letter for your perusal, as I feel it my duty.

After our President was assassinated last Friday in Dallas, Texas, a suspect was apprehended in a local theater. This man, Oswald, allegedly killed our President. However, until his death, last Sunday, he denied he assassinated President Kennedy.

Learning from history, a murderer like that, would, in his frame of mind, most likely have, not only admitted the brutal crime, but would also be proud of same. This man was not and we must consider the possibility that this man was, either framed, or used by a group of conspirators as diversion manouevre.

Assume that the police officer, who apprehended Oswald did not speak the truth, when he said Oswald tried to kill him in the theater. The various evidences were all circumstantial. Indeed he, Oswald may have had the task to focus attention to himself, while others could, in the meantime, erase all evidence which could have lead to them.

Oswald was an ideal person for that. His background, his stay in Russia, his experience in the Marines, etc. All this must have been known to authorities and others using him. The fact that he was employed in the building from which the fatal shot was fired, it all was a (too) perfect set up.

After two days of interrogation, the Dallas police made an announcement that they would move Oswald to the county jail, Sunday, 10:00 AM. If he was not the killer, it would have been revealed. But now, a shady character, Ruby or Rubinstein, well known by the police, is able to kill Oswald while the guarding detectives conveniently look the other way, where they could have prevented the killing by simply slapping the hand of Rubinstein down.

RESPONSE

Considering all what happened, one cannot help feeling that there was indeed a conspiracy of several persons, at least. The fact is that our President was indeed loved and respected by Democrats and Republicans alike and only a small minority was against him, still one cannot accept that even derailed persons would assassinate the President.


