ASSASSINATION OF PRESIDENT KENNEDY, NOVEMBER TWENTYTWO, ONE NINE SIX THREE, DALLAS, TEXAS.

RE BU TEL NOVEMBER TWENTYTWO NINETEEN SIXTYTHREE.

[U. S. PROBATION OFFICER CHESTER MC LAUGHLIN] EL PASO, SUGGESTED NAME OF GARY EDWARD PETERSON AS ^{TEXAS} FALLING WITHIN CATEGORY OF BUREAU INTEREST RE CAPTIONED MATTER. PATERSON IS SUBJECT OF BUFILE NINE THREE THREE ONE THREE SEVEN. WAS CONVICTED IN USDC, EL PASO, AUGUST, NINETEEN SIXTY FOR EXTORTION VIOLATION INVOLVING THREATENING LETTER TO HIS MOTHER. PETERSON RECEIVED [REDACTED] AND PLACED ON SUPERVISED PROBATION WHICH ENDED EARLIER THIS YEAR. [USPO MC LAUGHLIN] STATED PETERSON OBTAINED EMPLOYMENT AS TRAINEE AT CURTIS MATHIS PLANT IN ATHENS, TEXAS, AND WAS LAST KNOWN TO BE AT THAT LOCATION.

[USPO MC LAUGHLIN] STATED HE BELIEVED PETERSON WROTE THREATENING LETTERS TO PRESIDENT OF U. S. WHILE SERVING IN ARMY ABOUT NINETEEN FIFTYNINE. EL PASO FILE INDICATED THAT SECRET SERVICE AGENTS FROM PHILADELPHIA CONTACTED HIS MOTHER, NORMA M. PETERSON OF ONE THREE ZERO SEVEN RIVERSIDE DRIVE, WILMINGTON, DELAWARE CONCERNING LETTER.
