

Police Hold Suspect

DALLAS — Lee Harvey Oswald, 24, a self-proclaimed pro-Castro Marxist who defected to Russia in 1962, was charged today with the assassination of President Kennedy. The ex-Marine denied he had anything to do with the crime.

Police also charged him with the murder of a pursuing patrolman shot down in the street shortly after Kennedy was fatally shot and Texas Gov. John Connally was wounded as they rode in a motorcade through Dallas.

Police said Oswald, battered and sullen, denied having anything to do with the assassination, but admitted he worked in the building from which the fatal shots were fired. He would not account for his whereabouts at the time of the assassination, police said. But police reported it had been established he was in the building when the fatal shots were fired.

Oswald was seized by police in a theatre in the Oak Cliff district of Dallas less than four miles from the scene of the assassination.

A policeman, J. D. Tippit, 38, was shot down in the street about five blocks from the Texas Theatre. The theatre cashier, Mrs. Julie Postal, reported to police that a suspicious man had entered the theatre. Four policemen, including Tippit, went after him.

After shooting Tippit, according to police, Oswald tried to
