SECURITY AND APPLIED FOR UNEMPLOYMENT BENEFITS.

MAY SEVEN FILLED OUT APPLICATION AT COMMERCIAL EMPLOYMENT AGENCY.
ALSO ON MAY SEVEN SIGNED UP FOR WEEKLY BENEFITS AT THE DIVISION OF

THURSDAY, JULY FOUR, A HOLIDAY. HIS TIME CARD REFLECTS HIS EIGHT HOUR
SHIFT VARIED FROM APPROXIMATELY EIGHT AM AND EIGHT THIRTY AM TO
FIVE PM OR FIVE THIRTY PM AND FROM NINE AM, NINE THIRTY AM OR TEN
