ON THIS DATE THOMAS HARRIS, ALLERTON HOTEL, CHICAGO PAREN TEMPORARY END PAREN, LEGAL RESIDENCE NINETEEN HUNDRED MEMOMONEE RIVER PARKWAY, WAUWATOSA, WISC., ADVISED THIS OFFICE FORMERLY RESIDED ONE ZERO FOUR FOUR THREE CROWN ROAD, APARTMENT SIX, FRANKLIN PARK, ILLINOIS. ON EVENING OF NOVEMBER TWENTY SIX, LAST OR EARLY MORNING NOVEMBER TWENTY SEVEN, LAST, OVERHEARD COUPLE IN APARTMENT SEVEN, NEXT TO HIS, HAVING ARGUMENT. HUSBAND SEEMED DISTRESSED OVER THEIR MARRIAGE. AFTER SEVERAL MINUTES ARGUMENT, STATED QUOTE MAYBE I OUGHT TO SHOOT THE PRESIDENT AND THE COPS WILL TAKE CARE OF ME END QUOTE.
