SIXTYTHREE. CALEY DENIED MAKING STATEMENT TO DON STANLEY
AND OR JOHN ADEMA, PLUMBING PARTNERS, S AND A PLUMBING
BUSINESS, PRINCETON, MINN., QUOTE SOON A HIGH GOVERNMENT OFFICIAL
WOULD BE ASSASSINATED UNQUOTE. HE DENIED INFERRING OR PREDICTING
SUCH A THING. HE ALSO DENIED MAKING STATEMENT PREVIOUS TO
