WAS ELECTED TO U.S. SENATE. HE REPORTED THAT IN ONE NINE FOUR
EIGHT PARR HAD ONE BILL MASON, EDITOR OF THE ALICE CHRONICAL NEWS

PAPER KILLED TO KEEP POLITICAL CONTROL AND THAT ONE SAM
SMITHWICK A DEPUTY SHERIFF WAS GIVEN A LIFE SENTENCE FOR HAVING
KILLED MASON. SMITHWICK LATER KILLED HIMSELF IN JAIL. ALSO

IN SAME YEAR PARR IS RUMORED TO HAVE TRIED TO HAVE ONE FLOYD
FLOYD KILLED. FLOYD OWNER OF RADIO STATION IN ALICE AND WAS
ATTEMPTING TO CONNECT PARR WITH MURDER OF MASON. THROUGH A

MISTAKE FLOYD/S SON WAS KILLED BY A SNIPER AND DURING COURSE
OF TRIAL OF THE MURDERER WHOSE NAME IS NOT RECALLED PARR
